General Summary

Positions in this broad class care for and maintain park and recreational grounds and facilities.

Distinguishing Characteristics

The journey level of this class typically performs all class duties. It is distinguished from the Horticulturist class by performing general maintenance duties and by not performing specialized horticultural activities such as species selection, planting design and/or plant propagation.

Typical Duties/Examples of Work

- 1. Ensures safety, cleanliness, and operability of park grounds and facilities.
- 2. Performs the full range of grounds maintenance; mows, rakes, edges and trims lawns, greens; ground trims trees; operates power movers, edgers, and other small grounds maintenance equipment; waters and weeds lawns, shrubs, and flower beds; assists in gardening work
- 3. Mixes chemicals and fertilizers according to predetermined formula and operates hand sprayers to apply chemicals and fertilizers to grass for the control of weeds and grass diseases.
- 4. Cleans, paints, and performs minor repairs on facilities, equipment and appurtenances; requests work orders for larger repairs.
- 5. Installs irrigation lines and makes repairs and adjustments as necessary.
- 6. Ensures overall safety for park users by inspecting grounds and equipment, removing or mitigating hazards, and requesting assistance as necessary.
- 7. As assigned, directs work of crews or work groups; responsible for worker or volunteer safety, review of work, training and guidance in duties.
- 8. Performs related duties as assigned.

The lead level of this class typically performs all class duties and in addition serves as a lead worker. It is distinguished from the Parks Technician class by the lead assignment. Note: This is a premium pay class for assignment of lead duties. Employees do not accrue seniority or obtain status in this class. Employee is assigned from a base class.
