Approved Recommended Code or Standards Revisions

- None today. Today is focused on planning for standards discussion.

Summary Notes

Approval of Summary Notes

- Minutes were reviewed but since they were late will be approved at next meeting.

Process for reviewing the Standards

- Chairs summarized the process in the coming months. Begin Standards review then come back to the code revisions. The code has not been finalized; we've completed our first review of the code.
- The question was posed by chair about what process to use. It's a longer document than the code.

Suggestions:

- Look at sections of code revision that have changed versus those that have remained virtually the same. We could change only those that had changed.
- Possibilities of subcommittees were discussed.
- Should Standards be minimal or more specific? Sometimes less prescriptive guidelines make it more challenging for neighborhoods.
- Standards should be immune from political manipulation.
- ONI staff could review Standards and meeting summaries for places where GREAT deferred inclusion and information to the Standards.
- Effective vehicle for increasing diversity should be at the coalition level not the neighborhood level. Collectively, coalitions would be able to get better resources.
- Send out staff's analysis of Guidelines and what needs to be changed.
- Neighborhood system has a unique role and there is a need to work with communities of color and underrepresented communities to understand distinctions and opportunities to collaborate.
- Don't want to duplicate services with the County.
- Collaboration will increase partnerships and support for the neighborhood system.
- Having trouble getting volunteers in general sometimes.
- Public meetings law issues need to be resolved. Is this committee taking this on?
- GREAT should have other evening meetings--possibly quarterly.

Decisions

- ONI will take on the public meetings law discussion. Signing ballots for votes is one key issue. Complaints about ADA compliance and neighborhood association meetings and notification are other issue.
- GREAT voted to organize ad hoc committee to look at the public meetings law and possible revisions. Motioned and seconded. Ray Hites, Leonard Gard, and Moshe Lenske will participate. Joleen Jensen-Classsen will lead the ad hoc committee for ONI.
- Organize a subcommittee to look at Standards and review and form the agenda for future meetings to guide the work of GREAT.
- ONI will work to get someone (possibly three) to attend GREAT with interest in Communities Beyond Boundaries.

- GREAT would like ONI to ask Cristina Germain to be part of the committee.
