Article 5: Optional Provisions

Old Town Chinatown Neighborhood Association Articles of Incorporation—Nonprofit

- This corporation is organized exclusively for charitable, religious, educational, and scientific purposes, the makes of distributions to such organizations that qualify as exempt organizations under §501(c)(3) of the internal Revenue Code, or the corresponding section of any future tax code.
- 2. No part of the next earnings of the corporation shall inure to the benefit of, or be distributable to its members, directors, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes of this corporation.
- 3. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on (a) by a corporation exempt from federal income tax under §501(c)(3) of the internal Revenue Code, or the corresponding section of any future tax code, or (ii) by a corporation, contributions to which are deductible under 170(c)(120) of the internal Revenue Code, or the corresponding section of any federal tax code.
