Procedural Justice Recommendation	<ul style="list-style-type: none">• A debrief of the Procedural Justice Recommendation that was approved at the PCCEP January 28th Public Meeting - next steps:<ul style="list-style-type: none">○ A Portland Police Bureau (PPB) representative goes over the process which includes: Recommendation is sent to the PPB and the Mayor, the police chief is provided a copy, the policy team + policy process, PPB drafts a formal response within 60 days, public comment (1st and 2nd universal review), final response is draft ad sent to the PCCEP.○ PPB will provide PCCEP with an update on Recommendations at the Committee’s monthly general body meetings.• Public Comment – where can the public find the draft responses?<ul style="list-style-type: none">○ The PPB Website under Directives○ The public can sign up for automatic emails on Directives - for submission of public comment.

	<ul style="list-style-type: none">○ Go to where people are, go out into the community and take meetings to the community.○ Community Outreach - follow up needed (Two Spirits, Pacific Family Circle, Latino Network, Muslim Advisory Council).○ Reach out to the African American Advisory Council.○ Develop a series of focus groups.○ An outreach budget will be given to all four subcommittees.○ Outreach to Universities (e.g. Portland State Universities Criminal Justice students).
