Part I Person Crime includes four offenses: murder & non-negligent manslaughter, rape, robbery, & aggravated assault.

NIBRS Person Crime includes 14 offenses: assault offenses (aggravated assault, simple assault, intimidation), homicide offenses (murder & non-negligent manslaughter, negligent manslaughter), human trafficking (human trafficking-commercial sex acts, human trafficking-involuntary servitude), kidnapping/abduction, sex offenses (rape, sodomy, sexual assault with an object, fondling), and non-forcible sex offenses (incest, statutory rape).

Part I Property Crime includes three offenses: burglary, larceny, & motor vehicle theft

NIBRS Property Crime includes 25 offenses: arson, bribery, burglary, counterfeiting/forgery, embezzlement, extortion/blackmail, fraud offenses (7), larceny offenses (8), motor vehicle theft, robbery, stolen property offenses, and vandalism.

The Portland Police Bureau switched to the National Incident Based Reporting System (NIBRS) in 2015. 2016 was the first full year of NIBRS reporting. The Part I crime rate calculations for 2015 and later uses a modified hierarchal counting method that is similar to the method used by summary reporting system in prior years. The Part I crime rates pre and post 2015 are not directly comparable due to differences in the requirements for collecting and reporting incidents in NIBRS. The NIBRS crime rate and the Part I crime rate are not comparable.

Statistics are accurate as of the date the data was accessed (08/12/19). The records used in the report are dynamic and may result in statistics varying from prior or future reports. The statistics presented in this report are sourced from RegJIN and may differ from those found in the FBI's Uniform Crime Reports.
