## New Building Code and Submittal Requirements for 1 & 2 Family Residential Prescriptive Lateral Design

To keep City of Portland building permit customers up to date on State of Oregon Building Code application submittal requirements, the Bureau is providing the following advance summary and notice of training opportunities for applicants submitting residential building permits for new structures and additions designed using prescriptive wall bracing.

**On October 1, 2011**, all applications for new residential structures and additions designed using prescriptive wall bracing will be required to meet the new application requirements of the 2011 Oregon Residential Specialty Code (ORSC). The additional information required by the 2011 ORSC will include separate Wall Bracing Floor Plans, a Building Construction Narrative, and Braced Wall Calculations.

The prescriptive wall bracing requirements of the 2011 ORSC have been completely rewritten and expanded from six (6) pages in the 2008 ORSC to thirty (30) pages of text, figures and tables. While the final design of a residential structure may turn out to be very similar, the code terminology and methods to determine minimum wall bracing requirements are entirely new.

The Bureau of Development Services (BDS) Handout, **Applying for a New Single Family Residential Project** will be updated to reflect the new submittal requirements.

**Note:** The 2011 ORSC was effective on July 1, 2011 with a three month grace period where the applicant may choose to comply with either the 2008 ORSC or the 2011 ORSC.

## BDS Inspection Services Division - Roll-Over Policy Update

Updated September 2, 2011 - For all permit inspections that cannot be completed in a given day, the caller (as identified in the building permit) will be notified via telephone no later than 9:00 AM on the day of the requested inspection to confirm that the inspection has been rolled-over.

Inspection staff will continue to contact customers each day to confirm one and two family inspections that are scheduled for that day.

**Note:** Inspections that are rolled over will take a higher priority the next business day.

The IVR message has been updated as follows:

*"Due to reduced staffing levels based on budgetary constraints we are currently unable to assure next day services for all called inspections. For one and two family projects: If we are unable to complete your inspection, your request will be moved into the next business day. This may result in more than a single day delay for some projects. Please note, you will be called if your inspection has been rolled over for the next day. The rolled over status will be inputted in the IVR system by 9:00 AM. Inspection staff will contact customers each day to confirm one and two family inspections that ARE scheduled for that day. We are sorry for any inconvenience this may cause and thank you for your understanding."*

## Public Works Permitting Update

In response to requests from permit applicants and staff, we are making a change to the timing and processing of requests for design exceptions and appeals. **Effective September 1st, 2011** a Public Works Appeal cannot be submitted until the City has provided a coordinated response to the project proposal that includes the requirements for improvements in the Right-of-Way (ROW). There are three ways to receive the City's coordinated response:

- Land use action with conditions of approval (such as a partition, conditional use, or zone change)
- Pre-application conference through BDS, or
- Public Works Inquiry

We will checksheet applications for building permit that haven't had one of these actions until a coordinated response through a City-initiated Public Works Inquiry is completed (10-day turnaround).

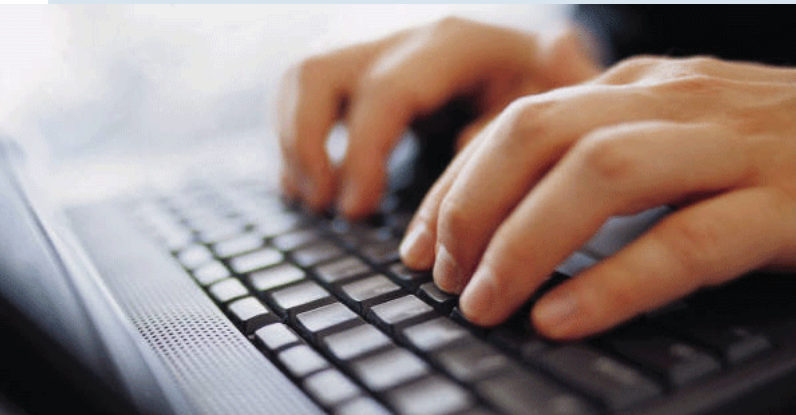

# ITAP Restarts & Moves Forward



In July, Commissioner Dan Saltzman and BDS Director Paul Scarlett informed employees that the Information Technology Advancement Project (ITAP) will be restarting.

Commissioner Saltzman and Paul Scarlett have decided to send the project through the City's open and competitive bidding process. The ITAP Team is currently preparing for the first step in the bidding process, which is developing a request for proposals (RFP).

The RFP process is anticipated to take several months. During that time, the review and documenting of BDS and development review bureaus' business processes will continue. By the time a contract is signed with a software vendor, the vast majority of the process mapping must be completed in order for the vendor to begin configuring and scripting the new software.

The ITAP Team and the bureau subject matter experts (SMEs) have been discovering that process mapping is very complex and time-intensive. It requires a meticulous review of current business practices, in-depth conversations with multiple work groups and individuals, and careful analysis. Such comprehensive review can sometimes reveal business practices that must be modified before they can be automated. Input from work groups and stakeholders will be sought for changes to business practices.

## ITAP Customer Advisory Committee Seeks Additional Members

In June, a group of professionals from a wide range of interests in development services began meeting to provide input on ITAP from the customers' point of view. The committee is currently seeking three to four additional members who have an interest in development review services. In particular, the com-

mittee would like to see a representative from a surveying company, one or two representatives from mid to large-sized construction companies, and a citizen who is interested in neighborhood safety and livability issues related to new construction and remodeling projects. Project Manager, Hank McDonald emphasizes, "We really need to hear from our customers and what their needs are for the automated services that ITAP will provide."

Work groups in all of the development services bureaus will continue to collaborate with the ITAP Team. The ITAP Customer Advisory Committee will then provide feedback on some of those processes. As business practices are reviewed, process maps developed, and a vendor is selected, ITAP will move closer to implementing the six deliverables:

1. Online permit application and plan review services.
2. Implementation of an updated building permit information system.
3. Mobile online access for field staff.
4. Digitization of historical permit and property information.
5. Online access to historical permit and property information.
6. Implementation of an automated queuing system.

## Replacing the Stormwater Discharge Code 17.39

The Bureau of Environmental Services (BES) plans to replace the city’s Stormwater Discharge Code 17.39 in September and is now developing specific Administrative Rules that clarify BES authorities and processes for the proper management of stormwater discharged into the city’s storm sewer and drainage system. While the code applies to all dischargers, the changes will primarily affect development on contaminated sites and discharges from unpermitted industrial facilities. The proposed code changes will clarify many of the current requirements as follows:

- Reorganize Code sections to clarify allowable discharges to stormwater.
- Add more information about prohibited toxic discharges to conform to permit requirements and to enhance protection of receiving waters.
- Expand the type and use of city discharge authorizations to include un-permitted discharges that would otherwise cause interference with or harm the city storm sewer and drainage system, contribute to a violation of the city’s NPDES stormwater discharge permit, degrade the local receiving surface water or groundwater or have a negative effect on human health or the environment.
- Clarify BES authority to require site modifications

and site plans prior to approval for discharge to a city system.

- Establish minimal review fees to administer city discharge authorizations and permits.

The proposed Code includes only minor policy modifications and can be viewed on the BES website at <http://www.portlandonline.com/bes/codereview>. BES expects a more complete public review and comment process on the administrative rules to implement these code provisions. The attendant rules will detail how BES decides to approve or disapprove discharge requests to the city system, and when city discharge permits or authorizations would be required. BES expects to release draft rules for review and public comment in late fall or early winter 2011.

The revisions to City Code are being made to ensure compliance with the most recent versions of city stormwater discharge-related permits and to ensure consistency with all relevant Federal and State regulatory language including National Pollutant Discharge Elimination System MS4 and Water Pollution Control Facility UIC permits.

Modifications will be designed to ensure that discharges to the MS4 and UIC systems are not only protective of the collection system and water quality of the receiving stream but also protective of sediments and habitat, and groundwater when discharges are directed to a UIC.

## “Cut Through the FOG”

Portland’s Bureau of Environmental Services (BES) is moving ahead with CutThrough the FOG in an effort to minimize impacts on Portland’s sewer system from fats, oils and grease (FOG) and other food waste.

CutThrough the FOG will change extra strength sewer rates and enforce existing Oregon State Plumbing Code requirements for Portland food service establishments that discharge high concentrations of FOG and food waste to the city’s sewer system.

The requirements will be phased in through late 2012 for existing businesses and starting January 1, 2012 will affect:

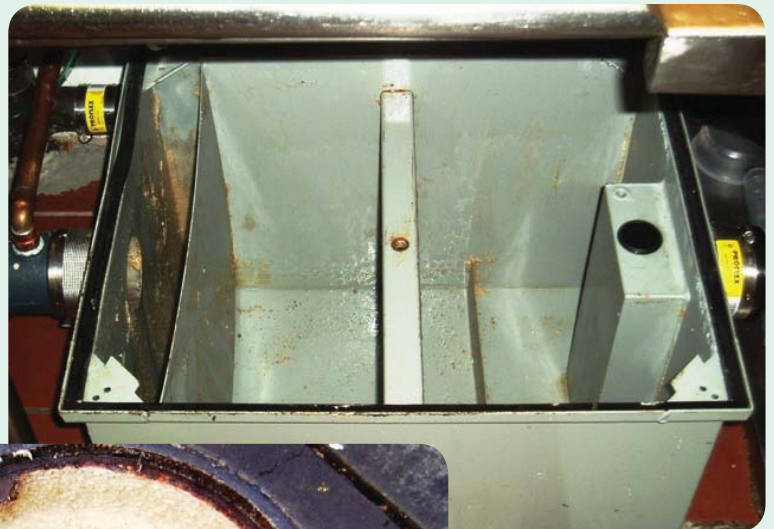
- New construction
- New ownership
- Changes in tenancy
- Remodels of food service establishments.

Food service establishments can earn extra strength rate reductions by implementing best management practices that include installing and maintaining grease reduction devices, removing food grinder disposal units, and participating in food composting and food donation programs.

Under City Code 17.34 and Oregon State Plumbing Code, food service establishments are not authorized to discharge FOG. New food service establishments will be required to connect all grease-producing fixtures to an appropriate grease removal device, aiming for zero FOG and food waste discharge to the city’s sanitary sewer system. Grease removal devices must be cleaned and maintained per manufacturer’s specifications and will require a sampling port and will be regularly inspected by city staff to ensure compliance.

FOG discharges to the sewer system in excess of 100mg/l will trigger enforcement actions and food service establishments may be required to increase cleaning frequency or provide other methods to reduce FOG discharges. Existing food service establishments without grease removal devices will be inspected to ensure FOG is not being discharged into the city sewer system. Food service establishments that are found in viola-

tion will be subject to fines of up to \$2,000 per day and will be asked to submit plans to reduce FOG discharges to 100 mg/l. Those choosing to install grease removal devices will be granted an appropriate period of time to come into compliance.



Ideally, under Cut Through the FOG all Portland food service establishments would plumb all FOG-generating fixtures to a single large capacity gravity grease interceptor, enlist help from a reputable pumping company to handle cleaning, maintenance

and required record keeping, remove all food grinders, and participate in food composting and food donation programs.

However, BES recognizes that optimum compliance will be a challenge for many food service establishments due to limitations on physical space and resources as well as the unique nature of each business and the community it serves. BES staff is available to help determine best options for each business.
