Transgender Inclusion 101 helps participants to gain a deeper understanding of the identities and experiences of transgender people, and develop a language around common gender concepts and pronoun best practices.

About Yee Won
Born and raised in Malaysia, Yee Won uses his lived experience as a political asylee based on sexual orientation, gender identity, and political opinion to uncover our commonalities and build on our collective expertise to create a just society.

Yee Won is passionate about using storytelling to change hearts and minds. His TEDx Talk, “Beyond the Gender Binary <<https://www.youtube.com/watch?v=-Lm4vxZrAig>>,” is used widely to spark discussions about gender. He actively works on expanding the definition of family through the Strong Family Movement. He has testified in front of Oregon state legislators and published “There’s More Than One Kind of Family — It’s Time Our Laws Include Everyone <https://www.huffingtonpost.com/yee-won-chong/theres-more-than-one-kind-of-family_b_6912736.html>” in HuffPost. He is currently working on “Trans Dudes with Lady Cancer,” a film documentary highlighting his personal experience navigating the healthcare system as a transgender patient.

He has coached NGOs staff and board on using racial equity strategies and helped government employees to create transgender-inclusive workplace. His clients include Bonneville Power Administration, Oregon Health Authority, Meyer Memorial Trust, Crag Law Center, Services & Advocacy for GLBT Elders, and Willamette Valley Development Officers.
