Hello,

I just had a meeting at the Mayor's Office and he is doing a Press Conference on Thursday, 9:30-10:30 AM in Council Chambers that he

wants me to attend with him.

I need to get some talking points to him tomorrow by 3:00 PM with the following info:

1. Data comparison of what permits or development review processes have gotten faster since the Mayor took office two years ago, and how much faster they are now:
  - \* Has any sub-set of permitting gotten faster? (Early results from Fast Track Pilot Project?)
  - \* Data on fewer hearings per project with the Design Commission? (Kim)
  - \* Data on faster Design Review decisions over the last two years? (Kim)
  - \* Data on fewer rollovers for certain types of inspections? (Dan)
  - \* Any other areas of faster permitting/review/inspections?
2. Current approximate total timeframe for NSFRs and for “typical” large Commercial Permits (new construction) – from intake to issuance.
3. Estimated approximate total timeframe for NSFRs and those same “typical” large Commercial Permits (new construction) – intake to issuance - once we’ve gone live with both ePlan and Review Windows (formerly Review Gates).
4. Three fabulous things we are going to deliver over the next year which our external customers will benefit from:
  - \* ePlan – please confirm the projected phases for me Dan
  - \* Public Portal – to allow customers to pay for permits, etc. remotely without having to travel downtown (is that reasonable to deliver by Sept. 2019?)
  - \* What else do you want to highlight?
5. The Mayor wants to promise that all affordable housing projects will have their permit review timelines cut in half. What is our current typical review time for those? What was it two years ago? (We can claim the improvement we already made in the last two years for PHB projects, plus maybe a little more.) We need to craft what it is that we can do for affordable housing projects, and divide it up by if it’s a PHB project vs just one of the projects complying with the Inclusionary Housing requirements. Suggestions?

I got a call from a regular customer (homebuilder), Justin Wood, who said BDS has changed how we're applying/inspecting the erosion control requirements, without having notified our customers (HBA, etc.) of our change, and without having done any training, or updating our info on the website, or the Simple Site Erosion Control form on the BDS website. Also, he thinks that it is excessive to interpret the code about what constitutes "construction activity on the site" as including things like a finish carpenter working on the interior of a house, and triggering the need for the applicant to keep a log regarding erosion control on those days.

He wanted to bring this issue to DRAC (the Development Review Advisory Committee) but I talked him down from that, and we'll have this meeting to discuss the issues instead. He definitely has pet peeve on when the City changes our interpretation/application of the regulations without telling customers, and they get surprised, and it causes them costly delays. So this one fell in that category for him.
