General Summary

Positions in this broad class obtain, classify, search and verify fingerprints of all individuals who are arrested in Multnomah County. These positions work in the jail, the juvenile facility and the Identification Division offices.

Police Identification Technician, Trainee - 30000303

Distinguishing Characteristics

The trainee level of this class typically assists with and learns the full range of fingerprint identification services.

Typical Duties/Examples of Work

1. Assists with and learns to obtain high quality fingerprints of adults and juveniles using electronic capture technology or inked prints; assists with and learns to obtain palm prints as requested for investigators; escorts individuals in the jail.
2. Assists with and learns to classify and search fingerprints against database fingerprints; learns to compare prints and make identifications.
3. Assists with and learns to write and distribute reports based on fingerprint identification.
4. Assists with and learns to verify identities.
5. Assists with and learns to distribute fingerprint, demographic and identification information to various city, county and state agencies for accurate record-keeping; Assists with and learns to perform criminal history checks and other research; maintains records and inputs information; duplicates and distributes materials.
6. Learns to testify in state and federal courts about fingerprint identifications in criminal matters, deportation matters, extradition hearings and identification hearings.
7. Takes visual images of juveniles; makes Police identification cards; assist officers in photo line-ups.

- 8. Assists with and learns to seal and expunge fingerprint and photo records by court order.
- 9. Provides a variety of back-up and peak-load support, such as answering and referring calls, assigning crime calls to investigators, accepting evidence and assisting the public.
- 10. Performs related duties as assigned.

Police Identification Technician - 30000304

Distinguishing Characteristics

The journey level of this class typically obtains high-quality fingerprints at the jail and juvenile hall, compares and identifies prints against database fingerprints, and provides testimony in court about fingerprint identifications. It differs from the

Trainee by being fully qualified and proficient to independently perform all aspects of the work.

Typical Duties/Examples of Work

1. Obtains high quality fingerprints of adults and juveniles using electronic capture technology or inked prints; obtains palm prints as requested for investigators; escorts individuals in the jail.
2. Classifies and searches fingerprints against database fingerprints; compares prints and makes identifications.
3. Writes and distributes reports based on fingerprint identification to support serving warrants, placing detainers, correcting jail records and assist in decision-making on release or detention.
4. Verifies identities; notifies jail of wrong identities based on fingerprint identification.
5. Distributes fingerprint, demographic and identification information to various city, county and state agencies for accurate record keeping; performs criminal history checks and other research; maintains records and inputs information; duplicates and distributes materials.
6. Testifies in state and federal courts about fingerprint identifications in criminal matters, deportation matters, extradition hearings and identification hearings.
7. Takes visual images of juveniles; makes Police identification cards; assist officers in photo line-ups.
8. Seals and expunges fingerprint and photo records by court order.
9. Provides a variety of back-up and peak-load support, such as answering and referring calls, assigning crime calls to investigators, accepting evidence and assisting the public.
10. Performs related duties as assigned.

Knowledge of: classification and identification of fingerprints

Ability to: read, interpret and categorize data with high degree of accuracy

Skill in: obtaining quality prints from potentially difficult subjects; a wide variety of law enforcement and fingerprint computer systems; making effective presentations in court

Police Identification Technician, Lead - 30000305

Distinguishing Characteristics

The lead level of this class typically provides lead direction and training to Police Identification Technicians and Trainees. It differs from the Police Identification Technician in its lead responsibilities, including quality control and input to performance. It also performs the work of the Police Identification Technician. Note: This is a premium pay class for assignment of lead duties. Employees do not accrue seniority or obtain status in this class. Employee is assigned from a base class.

Typical Duties/Examples of Work

1. Provides lead direction to staff; schedules work, approves vacations, posts, assigns and equalizes overtime; orders mandatory overtime as necessary; reviews time sheets.
2. Reviews fingerprint quality and interpretations; takes or recommends corrective action as appropriate.

3. Addresses and resolves or recommends resolution of staff personnel problems; reports to supervisor as needed.
4. Provides training of new technicians during shift.
5. Provides input during formulation and review of Standard Operating Procedures and bureau general orders as they relate to fingerprint identification operations.
6. Develop and implement improvements to service and communication.
7. Establish priorities for tasks and coordinates duties of technicians during shift.
8. Performs related duties as assigned.

Required Knowledge, Skills and Abilities

Knowledge of: effective principles and practices of leadership

Ability to: schedule and assign the work of others

Skill in: demonstrating techniques to others; providing training to others; providing lead direction to staff; including assigning and reviewing work
