Preventive Care Initiative Reminder

For Nonrepresented, PPA, PPCOA, Housing (AFSCME 189-3), BOEC, PTE-17 (formerly COPPEA), Recreation, Portland City Laborers (PCL), and DCTU represented employees enrolled in the City's health plan:

You have until January 31st, 2018 to visit your primary care provider for a preventive wellness exam (also called a checkup or physical) to maintain the lowest premium share for the upcoming benefits year.

- If you have received a letter confirming you met the Preventive Care Initiative (PCI) from Moda or Kaiser, there is nothing else you need to do now.
- If you have recently visited your provider or scheduled your appointment and will see your provider before January 31, 2018, Moda and Kaiser will send you a letter once your claim has been processed.
- If you are a Kaiser participant, you are required to complete and return the [Kaiser Authorization](#) form for the City to program your premium share correctly during annual enrollment in 2018 and for Kaiser to confirm to you that you have met the Standard. Kaiser participants can logon to their www.kp.org account to view previously sent letters.
- Moda participants can contact the Member Health Advocate at 855-466-6340 or email cityadvocate@modahealth.com with questions or to confirm status.
- If you are a newly hired employee (any time in 2017), you have until December 31, 2018 to meet the standard and this current deadline does not affect you or apply to you.

Taking the time to get these valuable screenings is an important step to better health and better health outcomes. We want everyone who desires to meet the PCI standard to have an opportunity to do so.

If you have not already met the Preventive Care Initiative standard and:

- Do not have a primary care provider; or
- Was told by your provider's office an appointment is not available until after January 31, 2018.

You are invited to make a confidential appointment with a qualified practitioner from Healthy Foundations (Moda) or a medical assistant from Kaiser who will provide a preventive care appointment at nearby worksites.

To secure an appointment, please read the following instructions:

- Dates, locations and health plan options are listed on the next page.
- CityCore, CityNet members please email cityadvocate@modahealth.com or call 855-466-6340 for available appointments.
- Kaiser members please go to www.kp.org/wellnessevent (Code: portland) to schedule an appointment
- No walk-ins will be allowed
- Employee's may use accrued sick leave to cover the appointment and associated travel time.
- No information about your appointment will be shared with the City, except that you had one.
- The worksite clinic will not provide ongoing care. You will be referred to a primary care physician for acute needs and follow-up recommendations will be given to your provider's office. This appointment will certify you meet the standard for the upcoming 2018/19 benefits plan year only.
