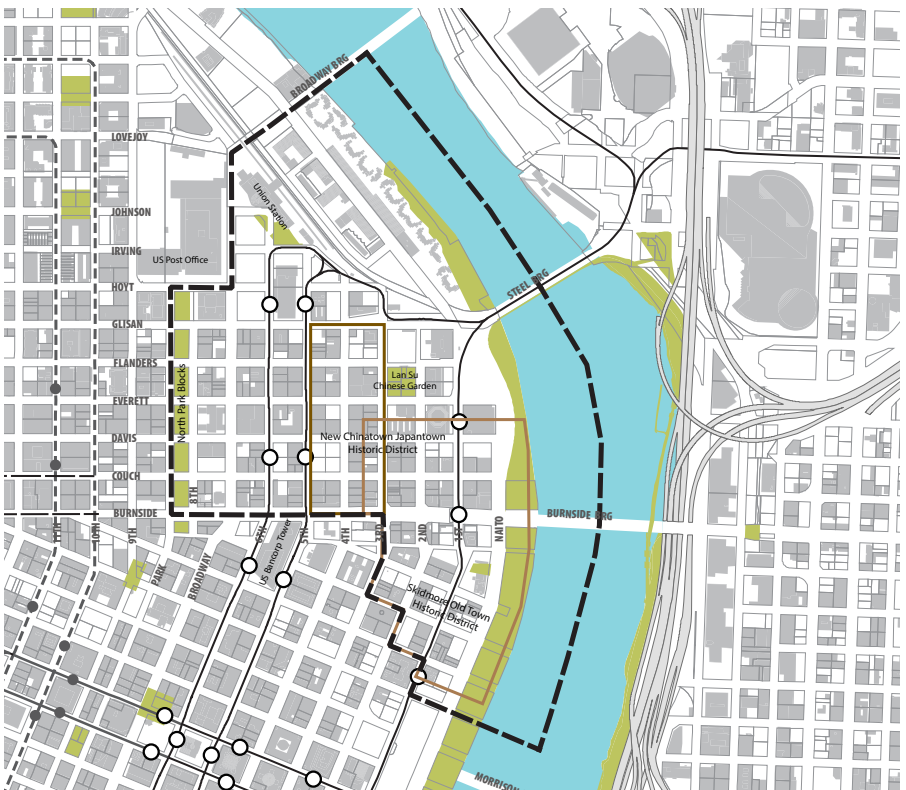

At the Concept Development Charrette:

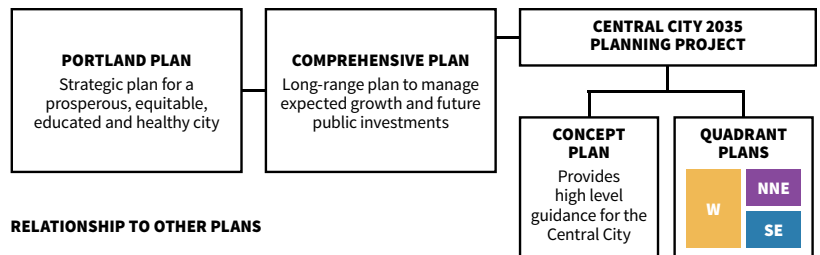
Roll up your sleeves with the project team to:
