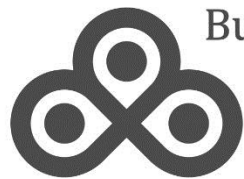

About this Document

In August 2015, the Bureau of Planning and Sustainability published a Recommended Draft of the 2035 Comprehensive Plan. The Recommended Comprehensive Plan incorporates changes based on public input as well as direction to and deliberation at the Planning and Sustainability Commission (PSC). City Council held five public hearings. The record for both verbal and written testimony closed on January 15, 2016. Testimony took the form of emails, letters, online comments collected through the MapApp, and oral testimony in public hearings. Over 2,000 individual comments were collected during that period.

After careful review, City Council suggested several amendments to the Recommended Comprehensive Plan. They accepted testimony on those amendments between March 18 and April 28, 2016.¹ During that period, over 1,500 individual comments were collected via the MapApp, emails, letters, and oral testimony in public hearings (April 14, 20, and 27, 2016).

This document provides an alphabetical (by last name) index of the written testimony collected on the Recommended Plan amendments. For ease of use, the overall record is divided into 6 volumes for online access (links below). The different volumes cover different date ranges (date of receipt) and they are organized in reverse chronological order:
