SUBJECT: CC2035 Work Session on February 14, 2017

The attached packet includes a set of decision tables and memos that staff will walk you through at the work session on February 14, 2017. As you will note, the packet includes a number of items that were on the January 10 and 24th agenda that you asked us to defer to future meetings. The topics on this work session agenda include part one of a set of amendments related to the bonus and transfer system, policy amendments including some related to family compatibility, river review, updates to the scenic resource code and ground floor bike parking. All of the materials for the work session are posted on the BPS website. The proposed agenda is on page 2 of this memo.

The agenda and the decision tables referenced in the agenda indicate which items are currently tagged for PSC discussion. Items are tagged either because a PSC member has indicated that they want to talk about it or staff would like to discuss it with the PSC. At the conclusion of each discussion item, we request that PSC make a preliminary decision to either support the staff recommendation, amend it, or provide guidance for next steps. At the last work session, we will ask the PSC to vote on all of the volumes as a package.

On February 28, 2017 we expect to discuss changes to the code that are necessary due to the adoption of the Inclusionary Housing Program, several transportation items carried over from January 10 and 24, amendments to the Master plan provision, among other items.

In late March 2017, staff will publish a Revised Staff-Proposed Draft based on PSC guidance. We will ask PSC to consider any final amendments and vote on the entire CC2035 on April 11, 2017.
