

# 82nd Avenue of Roses

## Development and Transportation Planning Fact Sheet

82nd Avenue is home to a diverse community of residents and businesses. In the context of growth and change, the City of Portland's Bureau of Planning and Sustainability (BPS) and the Oregon Department of Transportation (ODOT) are evaluating focus areas on 82nd Avenue between NE Killingsworth Street and SE Johnson Creek Boulevard to help identify future opportunities to improve quality of life for residents and businesses along the corridor.

The Oregon Department of Transportation's Plan focuses on future walking, biking, and safety improvements while the City of Portland's plan focuses on redevelopment, mixed use and employment opportunities in key areas. Key goals for each project are listed below:

### ODOT's Project Goals

- Identify projects to improve safety for people walking, biking, using mobility devices, taking transit, and driving on 82nd Avenue that could be funded and building in the next 5-10 years
- Develop improved street crossings and associated investments in four priority areas

### City of Portland's Project Goals

- Link community development objectives and street design
- Analyze development potential and barriers to development at typical sites within six focus areas
- Identify strategic and representative landuse study area
- Recommend actions and phasing to promote development

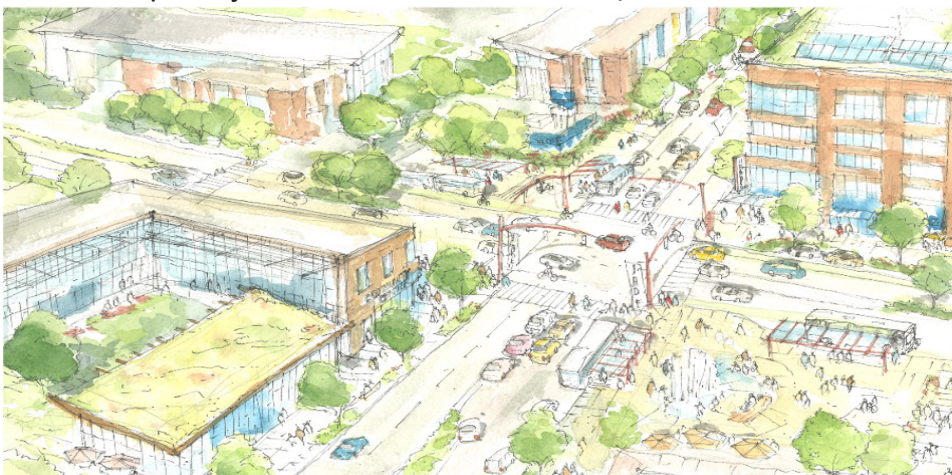
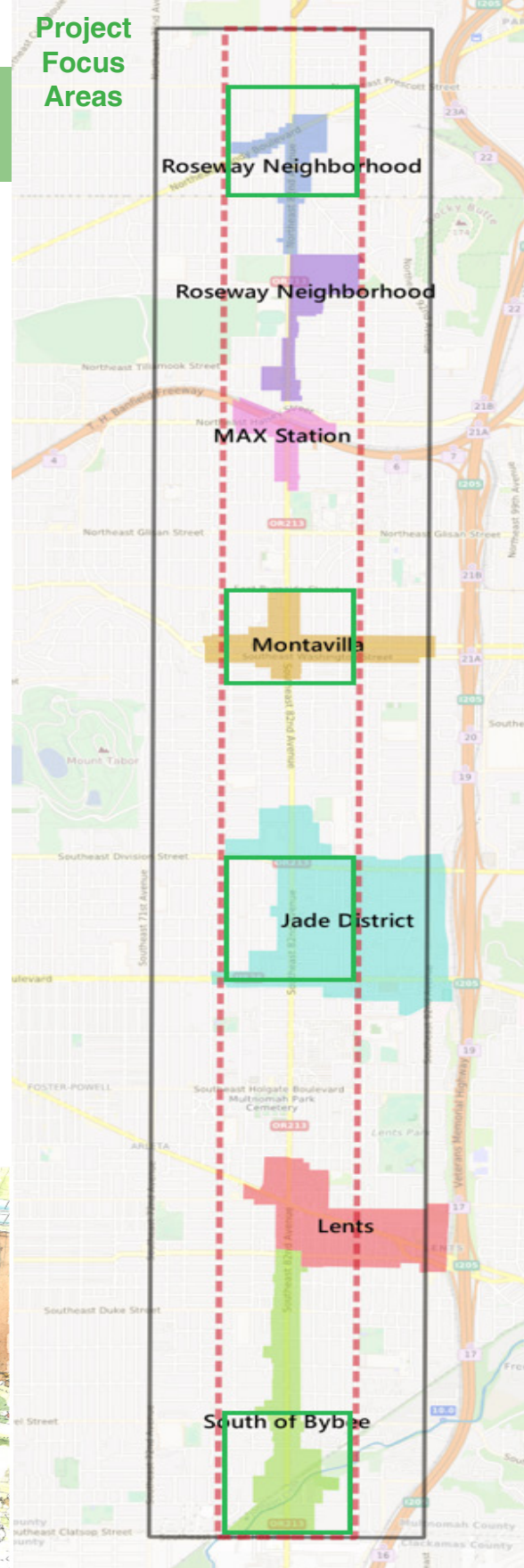
