

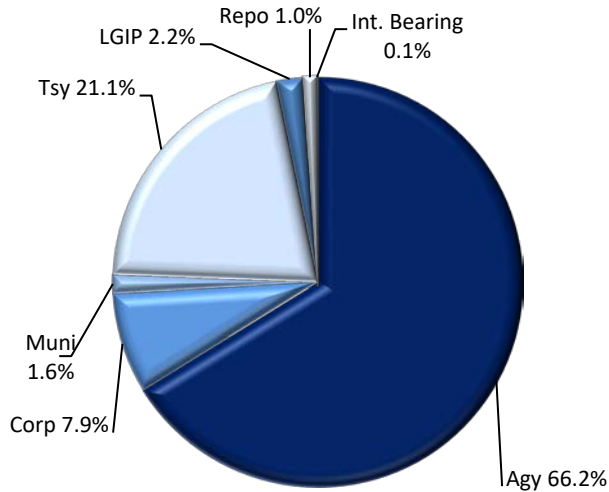

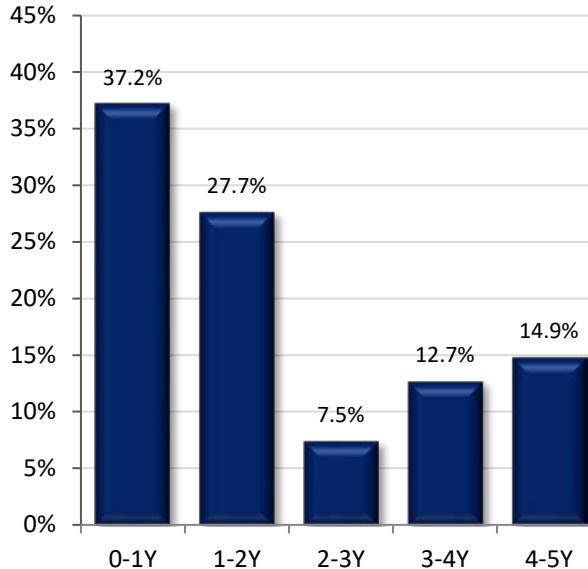

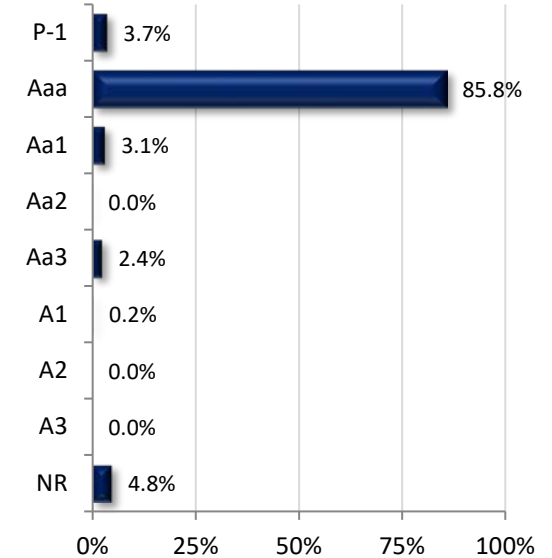
**SECTOR ALLOCATION**

**CREDIT QUALITY (MOODY'S)**



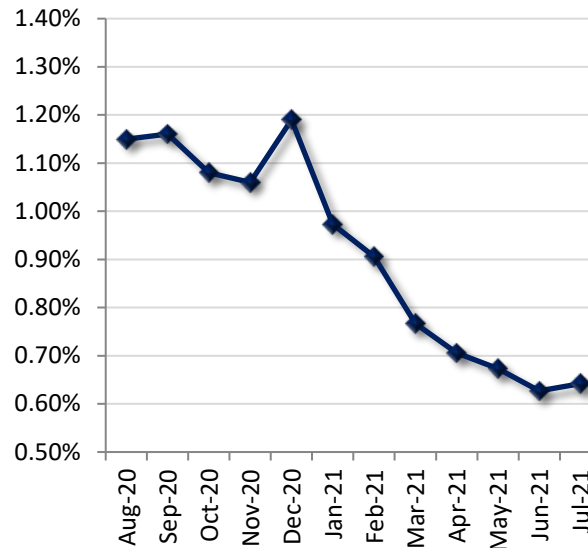
