The Treasury Division of the City of Portland (“City”) is determining which broker/dealer firms and affiliated registered representatives shall be eligible to conduct investment transactions with the City.

To be considered for inclusion on the City’s Approved Broker/Dealer List, please submit the following information **no later than April 8th, 2022**, to the email below.

For New Organizations:

1. Proof of registration with all federal and state regulators (SEC, FINRA, SIPC, etc.).
2. Most recent audited financial statements.
3. FINRA Focus Report filings.
4. If Applicable: Proof of State of Oregon Minority, Women’s, Emerging Small Business certification. Proof of U.S. Department of Commerce Minority Business Development Agency certification; U.S. Department of General Services Office of Small Business Certification and Resources; or other similar federal government certification (if applicable).
5. Supplemental information evidencing:
 - a. Understanding of and experience with State of Oregon statutes related to allowable investments for public sector; ORS 294 and 295.
 - b. Area(s) of specialization, products and services.
 - c. Economic research and other resources available to clients.

For Each Registered Representative Assigned to Sales Coverage for the City:

1. Complete copy FINRA BrokerCheck report.
2. Proof of licensure by the State of Oregon.
3. Relevant public sector investing and fixed income experience.
4. Certification in writing that they have read, understood and agree to comply with the [City of Portland Oregon Investment Policy](#).
