## Services Description FY 2016-17

The Division provides an array of financial management, communications, and project management services to OMF bureaus and divisions, Citywide projects, several small bureaus, and City Council offices.

Business Operations is made up of several teams; descriptions and an organizational chart are shown below:

### Financial Management Services

BHR/BRFS/CAO/Council Offices – Financial management services for the Bureau of Human Resources, Bureau of Revenue and Financial Services, Spectator Venues, Business Operations, the Office of the Chief Administrative Officer, all City Council offices and one program.

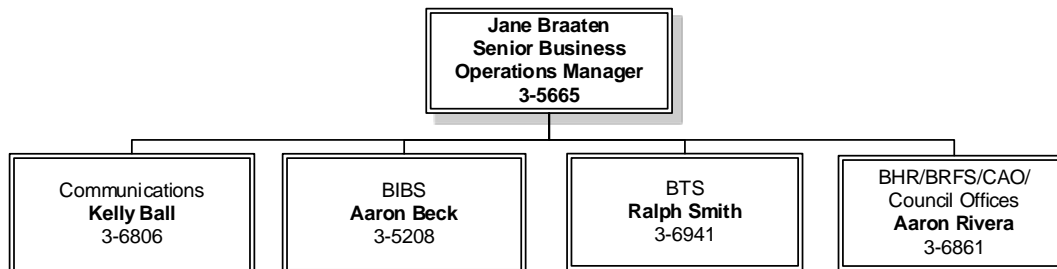
BIBS – Financial management services for the Bureau of Internal Business Services (CityFleet, Facilities Services, Printing and Distribution, Risk Management) and the Public Safety GO Bond program.

BTS – Financial management services for the Bureau of Technology Services, Enterprise Business Solution and the Public Safety Systems Revitalization Program.

Communications – Communications, change management, strategic planning, public information, project management and community involvement services.

Administrative Services – Personnel transactions, timekeeping services, FMLA processing, reception and procurement.

Management – Policy development, project management and support to special projects.
