The Office of Government Relations is seeking a BuMP request for \$20,778 in ongoing funding for a new position of Federal Assistant. We anticipate that the majority of funding for the position (\$35,000) will come from salary and other identified budget savings for the fiscal year.

This position would assist the Director with the preparation and implementation of the city's federal legislative agenda. Specifically, the position would be primarily responsible for federal research, analyzing federal legislation, drafting federal correspondence, monitoring legislation, preparing advocacy materials, and preparing and reviewing city comments on legislation and rulemaking, monitoring national media, and providing other support as needed to the Director, council offices, and bureaus. This position will supplement our current federal government relations efforts.

The position would be based in the Portland office of Government Relations.

FY 09-10

Coverage of state legislative issues: The ambitious agenda that the City Council and Bureaus seek at the state level continues to swamp the lobby staff so that coverage of some important issues are not adequately addressed during the legislative session. Due to budgetary constraints Government Relations is not asking for additional funding for an additional lobbyist at this time and may need to narrow the scope of the legislative agenda in the 2011 Session.

Bill Tracking and Response: The Office of Government Relations is currently working with BTS to upgrade our current Legislative Tracking System. We are attempting to utilize the State of Oregon's Legislative Bill Site to our advantage by enabling system to "grab" the information off of the Legislature's site with little manual input from an Administrative person. This will reduce typographical errors in the tracking system which should help users when responding to bills.

Agenda Development: The Agenda development for the State legislative session occurred too late in the cycle to adequately prepare for the upcoming Legislative session. Additionally, community involvement in the agenda building process occurred too late in the process. The Bureau will accelerate public outreach and issue identification. The Office of Government Relations has done long range forecasting to start the Agenda development process much earlier for the 2011 Legislative Session.

FY 10-11

Coverage of state legislative issues: The City Council and bureaus have continued to pursue aggressive legislative agendas at both the state and federal levels. The lobby staff is inundated with issues at the legislature and with administrative agencies, and adequate coverage of the vast number of issues continues to be a challenge. We are building an ambitious agenda 2011 Legislative Session and the Director will need to split her time between managing the state and federal legislative programs. We are asking for a position that will assist the Director with the preparation and implementation of the city's federal legislative agenda. Specifically, the position would be primarily responsible for federal research, analyzing federal legislation, drafting federal correspondence, monitoring legislation, preparing advocacy materials, and preparing and reviewing city comments on legislation and rulemaking, monitoring national media, and providing other support as needed to the Director, council offices, and bureaus. This position will supplement our current federal government relations efforts

Bill Tracking and Response: Government Relations is currently working with BTS to upgrade our Legislative Tracking System. However funding limitations and limitations on our BTS programmer prevents us from upgrading some of the features of this system. We will continue to make improvements to the system as funding becomes available.

Agenda Development: Council asked that we develop the City's Legislative Agenda earlier in the year to allow community involvement in the agenda building process. As a result, Government Relations moved up the legislative planning calendar and developed a three-part community involvement strategy to ensure adequate community involvement in the state legislative agenda. Government Relations did so by diverting existing resources in the current budget to this process.
