BUREAU NOTES

Overview

PF&R promotes a safe environment for all people who live and work in Portland and the surrounding areas. It provides an extensive range of public safety services including fire prevention; public education; response to fire, medical, and other emergency incidents. In FY 2016-17, PF&R had 717 full-time employees (FTE) and an adopted budget of \$117 million.

Each fire & rescue station is responsible for a specific part of the city called a Fire Management Area. Services are delivered 24 hours a day, 365 days a year from 31 stations strategically located to provide emergency response throughout the city. Stations overlap and support one another to ensure a seamless response.

Level Of Service

The map shows response times at the 90th percentile within each of the Neighborhood Coalitions for FY 2016-17. Response time is the incident-based time interval between the first PF&R unit dispatched and the first PF&R unit on scene. Response times are measured at the 90th percentile, which means that 90 percent of the time PF&R responds within the response time listed under "Level of Service."

Map Discussion

The map indicates PF&R's response times throughout the city were consistently longer than the 5 minute and 20-second target in FY 2016-17. Response times were best in the central city core and eastern sectors where the terrain is relatively flat, and multiple access options exist from different directions. Response times increased across the city compared to FY 2015-16, largely because winter storms and icy conditions in December and January caused slower travel times.


