Revenue Discussion

Fund 100 - PBEM anticipates undercollections in General Fund Discretionary, commensurate with underspending. All other revenues will be collected at budgeted levels.

Revenue Risks

Fund 100 - No expected risks to anticipated needed revenues at this time.

Expenditure Discussion

Fund 100 - PBEM has turned its focus toward the Coronavirus pandemic and halted non-essential spending. The bureau anticipates having significant savings in external materials and services because of this.

Expenditure Risks

Fund 100 - There is likely to be unplanned overtime due to the Coronavirus pandemic. This year-end projection includes a \$50,000 appropriation on top of regular year-end projections for personnel to prevent overspending. This adjustment was achieved by truing up the rent budget, which is 50% allocated to grants, and reducing EMS by \$7,000.
