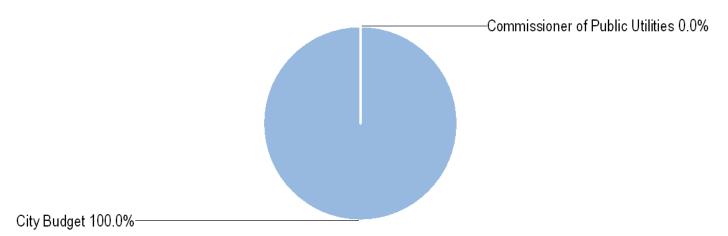

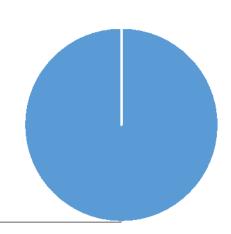

The Commissioner of Public Utilities is charged with legislative and administrative responsibilities in accordance with the provisions of the City of Portland Charter. The Commissioner is one of five nonpartisan City Council members. As a whole, the Council promotes a livable and sustainable city by enacting and enforcing City laws, approving a budget, and advocating for policy changes and funding at the state and federal levels. The Commissioner provides leadership and management oversight for a portfolio of City bureaus.

#### **Program Description & Goals**

The Commissioner is one of five nonpartisan City Council members. As a whole, the City Council promotes a livable and sustainable city by enacting and enforcing City laws, approving a budget, and advocating for policy changes and funding at the state and federal levels. Specifically, the Commissioner of Public Utilities provides leadership and management oversight for the following portfolio of City bureaus:

- Portland Parks & Recreation
- Bureau of Planning and Sustainability
- Office of Community Technology
- Open and Accountable Elections Program (per City Code)

The Commissioner of Public Utilities does not have any performance measures; however, the bureaus she manages have multiple performance measures which are one component of measuring success. Elected officials serve four-year terms and ultimately the voters decide at the ballot whether the Commissioner should serve another term if they seek reelection.

#### **Equity Impacts**

The Office of Equity and Human Rights (OEHR) presented Racial Equity Goals and Strategies to City Council on July 8, 2015. The City Council unanimously adopted the goals and strategies as binding City policy, providing a guidepost for City employees and leadership to follow to achieve the racial equity goals. Below are the Citywide Racial Equity Goals and Strategies along with examples of how the Commissioner of Public Utilities meets these goals:

- 1. Use a racial equity framework: The Commissioner's Office uses a racial equity framework to inform all its policy analysis and development work.
- 2. Build organizational capacity: The Commissioner's Office seeks to help community-based organizations build leadership skills and secure resources.
- 3. Implement a racial equity lens: The Commissioner's Office utilizes a racial equity lens to inform all its policy analysis and development work.
- 4. Be data driven: The Commissioner's Office utilizes data to inform all its policy analysis and development work.
- 5. Partner with other institutions and communities: The Commissioner's Office partners with dozens of community institutions and groups.
- 6. Operate with urgency and accountability: The Commissioner's Office is reminded daily that it is directly accountable to Portlanders.

#### **Changes to Program**

In May 2020, Carmen Rubio was elected as the Commissioner of Public Utilities for a four-year term starting January 1, 2021.

In December 2016, Council adopted the Open and Accountable Elections Fund, which created a matching funds program for qualifying candidates. The Elections Fund management is assigned to the Commissioner of Public Utilities and will remain with this office through 2021.

#### **Budget Narrative**

**Resources** The Commissioner of Public Utilities receives a General Fund Overhead and

Discretionary target allocation each year from the City Budget Office. The target may be adjusted annually for items such as cost-of-living adjustments, PERS rates,

and inflation.

**Expenses** The primary expense for the Office is staffing. Personnel costs make up 77% of the

budget. Internal and external materials and services resources to support the

personnel are also included within each Council Office.

**Staffing** The Commissioner of Public Utilities has 10.0 FTE, 2 of which are housed in the

Commissioner's Office and allocated to the Open and Accountable Elections fund. The biggest change to staffing over the past several years has been the creation of the new Senior Commissioner Staff Representative classification. This new classification, along with the associated funding, has created the flexibility for the Commissioner of Public Utilities to retain higher-compensated staff members who might otherwise find other employment inside or outside the City.

#### Requested Budget & Racial Equity Plan Update:

The office's budget is primarily personnel costs. Commissioner Rubio is the first Latina Portland City Commissioner in the city's history and has assembled a racially and culturally diverse, multilingual team that represent underserved Portland communities. The office will strive to improve engagement and service to Black, Indigenous, immigrants and refugees, people of color, LGBTQIA+ communities, and people with disabilities. And, with a focus on addressing the inequities that exist for communities related to housing, climate action, education, community safety, parks, planning, and digital equity.

The budget includes funds to support engagement activities with BIPOC community members. Commissioner Rubio and her team are committed to making local government more accessible to BIPOC and other historically underserved communities and to build greater trust and support community self-determination.

#### **Requested Budget Community Engagement:**

The office started in January 2021 and did not have the time to engage with communities in creating the requested budget. As mentioned, however, racial, economic and disability justice is a priority for this office and resources (i.e. staff time) will be dedicated towards addressing inequities in housing, climate action, parks, planning, community safety, education, and digital equity.

Commissioner Rubio oversees Portland Parks & Recreation, the Bureau of Planning and Sustainability, and the Office for Community Technology. The bureaus have Budget Advisory Committees that review their respective budgets and expect the bureaus to be engaged with the above communities.

#### **Base Budget Constraints:**

The office has limited discretionary resources located with the External Materials and Services major object code for community engagement and staff professional development. Additional funding would allow the office to do robust outreach and providing funding for every staff member to purse professional development that promote the equity goals of the City.

The office is new and has not yet established an approach to track program access and service outcomes for different populations.

#### Hiring, Retention, & Employment Outreach:

Commissioner Rubio is the first Latina Portland City Commissioner in the city's history and has assembled a team that includes three staff, including the Chief of Staff, who identify as Latino two staff who identify as Asian, and one staff who identifies as Black. All together, total staff of color (including the Commissioner) comprise 75%. The Office has staff who share values centering racial justice, economic justice, community and equity in policies, communications, engagement and other actions.

#### **Contracting Opportunities**

#### **Engaging Communities Most Impacted by Inequities**

The budget allowed the hiring of racially and culturally diverse, multilingual staff who bring lived experiences as members of communities impacted by inequities. This includes staff who are in multiple senior level positions. All staff share in the responsibility to engage impacted communities, and two staff will be dedicated to this effort. The budget includes a small level of discretionary funding which can be used to engage these communities in multiple ways.

#### **Empowering Communities Most Impacted by Inequities**

All staff share in the responsibility to engage impacted communities and to strengthen relationships with community-based organizations and community leaders. The budget includes funds specifically to support community engagement activities, multilingual outreach and coalition building.
