**Articles of Incorporation
Far Southwest Neighborhood Association**

ARTICLE 6: Distribution of assets on dissolution or final liquidation:

In the event of dissolution of this corporation, after adequate provision has been made for payment of all debts and liabilities of the corporation; its remaining assets not being required by law or conditions imposed by any donor to be otherwise applied or distributed, shall be disposed of by the Board of Directors to such organization or organizations organized for purposes similar to those of this corporation and operated exclusive for educational and charitable purposes as shall at the time qualify as an exempt organization or organizations under Section 501 (c)(3) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law.) Any such assets not so disposed of shall be disposed of by the Circuit Court of Multnomah County, Oregon, exclusively for such purposes, or to such organization or organizations as said Court shall determine which are organized and operated exclusively for such purposes.

ARTICLE 9: Optional Provisions

Limited Indemnification

Far Southwest Neighborhood Association shall indemnify directors, officers, committee members and staff to the extent allowed by law but limited to the face values of its liability insurance.

Limited Liability

A director, officer, or committee member of Far Southwest Neighborhood Association shall not be personally liable to the corporation or its members for monetary damages for conduct as a director, officer, or committee member. This provision shall not eliminate or limit the liability of a director, officer, or committee member for:

- A. Any breach of their duty or loyalty to the corporation or its members;
- B. Acts or omissions not in good faith or which involve intentional misconduct or a knowing violation of law;
- C. Any unlawful distribution;
- D. Any transaction from which they derived an improper personal benefit; and
- E. Any act or omission in violation of the Oregon State law regarding standards of conduct for nonprofit corporation directors, officers, or committee members.
