Organization: Native American Youth and Family Center (NAYA)

GOAL: Community Involvement, Increase the number and diversity of people who are involved and volunteer in their communities and neighborhoods.

Learning exprience

• Several of our members applied for positions on the Multnomah County Board of Property Tax Appeals. While these individuals were not selected, the process did result in a Native American being chosen for the board. The tax appeals board is now 44% people of color. Participation in that process provided us with an awareness of additional systems and processes for participation and outreach. PYEC members continue to work to find positions on City and County entities that allow for our culturally diverse members to participate and share their expertise in defining the problems and barriers that hold us at the margins and suggest solutions that will impact change. We continue to hold discussions with the DCL partners to determine how to successfully identify possible entities for which representation of our members would most meet the needs of our community.
