1. Please describe how your business will ensure that no one under the age of 21 is admitted, and how your business will educate patrons on the risks of marijuana use by minors.

1) Clear and easy to read signage is visible from outside the shop that states the premises are restricted to persons over the age of 21.

2) Customers are asked for identification at the reception desk. The receptionist verifies that the ID is valid, unexpired, governments issued, and that the customer is over 21 years old.

3) At checkout, the customer is asked to show their ID again. Information/warning cards are included with purchase to increase awareness of underage consumption.

2. Please describe how your business will prevent cannabis products from being consumed around or near your business.

1) Our business is located within a high-traffic strip mall. Aside from checking ID, the receptionist also watches the surveillance cameras and will notify one of our staff members who is a formally trained security expert if there is suspicious behavior. Sometimes our security staff works inside the shop, sometimes they act as a bouncer at the door. The real concern is the amount of other drugs that are obviously being used in the neighborhood. It is common for my staff to find hypodermic needles or baggies of strange white powders in the surrounding area. We hope that the surveillance and presence our shop provides actually helps to decrease the abundance of harmful substances in our area.

3. Please describe how your business will prevent and address potential negative impacts to neighborhood livability such as noise, parking, garbage, or loitering from your patrons.

As mentioned above, our business is located in a high-traffic strip mall that was designed to accommodate parking. The intersection the strip mall is located on is one of the busier roadways in Portland. Our patrons are instructed not to loiter or cause problems for the neighborhood. Our security system, especially the presence of video cameras, serves as a deterrent to criminal activity. Over the years, our business has provided Portland Police with video evidence of other crimes (not related to our dispensary but things that have occurred within our parking lot) and been able to assist with investigations.

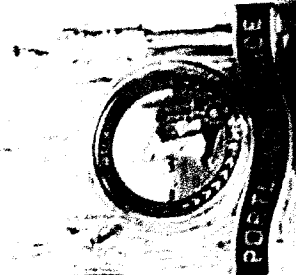
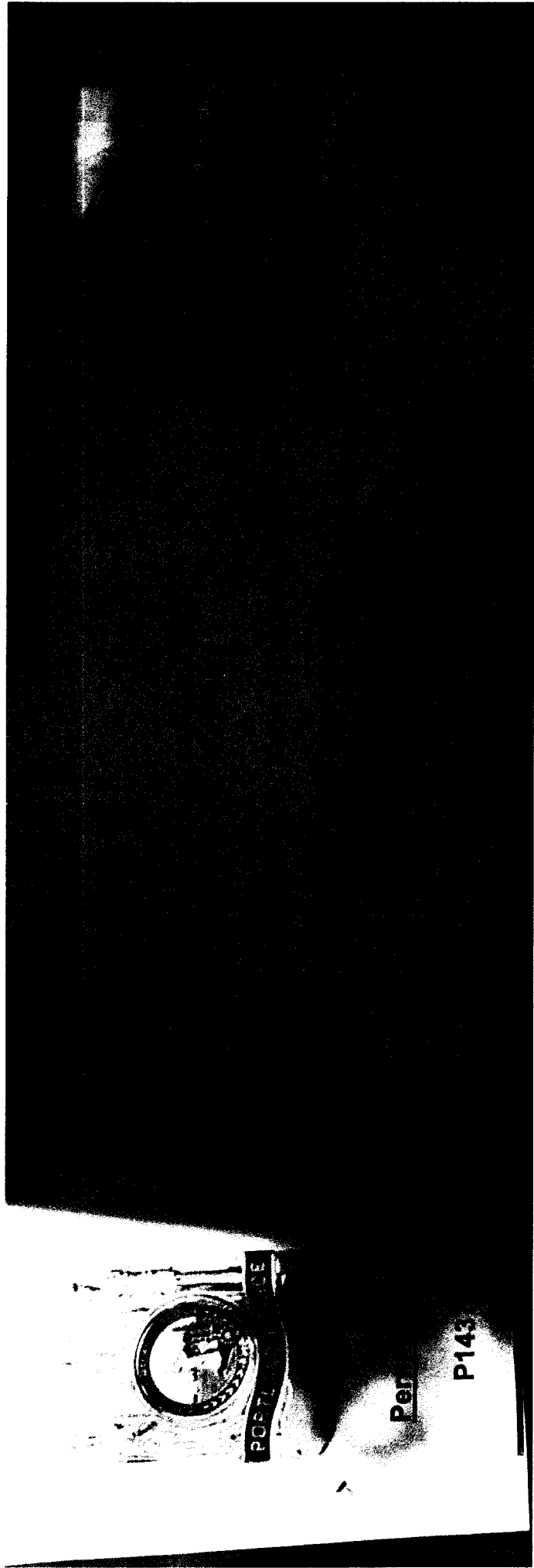
4. Please briefly describe your business's process to respond to and resolve complaints and/or concerns from neighboring businesses or residences.
