Exterior signage on front door informs public that patrons must be 21-years old to enter.

There is a single entry into reception area which contains no products for sale.

At reception desk, government issued Identification is scanned and verified, by machin e and human.

After verification of ID, then patron is buzzed through locked door to showroom containing merchandise for sale.

Emplyees have been trained on recognizing fake IDs and are instructed to call Portland Police if someone under 21 refuses to leave premises.

Use of posters and marijuana warning cards help educate patrons on the dangers of marijuana to children.

- 3) Two limited duration parking spaces in front of dispensary discourage patrons from parking in front of neighbors' properties.
- 4) Botanica owners have contracted additional trash pickup service to prevent build up of trash.
