Reception Room - Staff check in every visitor from behind a security slip-through window. Staff will always request a valid photo ID to verify legal age. After verifying ID, the customer is granted access through a locked, electronic "buzzer" entry door to the sales floor. Any visitor that is not able to produce valid ID proving they are of the minimum age are denied entry.

All required signs and other postings to warn customers that in-store and public consumption is illegal are conspicuously placed throughout the licensed premises. Staff have been trained to look for customers who may attempt to consume products in or about the premises and will demand that the customer leave the premises if caught attempting to do so.
