PBB Retail Minor Control Plan

- Training as to sanitary requirements under OAR 845-025-1620;
- Training as to retailer operational requirements under OAR 845-025-2820;
- Ensuring required training under CTS requirements is obtained;
- Ensuring employees required to obtain a marijuana handler permit under OLCC administrative rules;
- Training as to security requirements;
- Training as to record keeping requirements;
- Training as to packaging requirements, including requirement for OLCC notification under OAR 845-025-7040;
- Training as to distribution of a Marijuana Information Card as required by OAR 845-025-2860 at the time of each retail sale; and
- Training as to components of the “Minor Control Plan” described in this document, below.

Minor Control Plan

PBB will prevent minors under the age of 21 from gaining access to any portion of the licensed premises or to marijuana items as follows:

- Prominently posting signs that read “No Minors Permitted Anywhere on This Premises” (in English and Spanish) at all entry points to the premises;
- Verifying a consumer’s age listed on an unexpired government-issued photo identification such as a driver license, passport, U.S. military identification card, or other state-issued identification card bearing the picture, name, and physical description of the person;
- Packaging marijuana items in child-resistant containers;
- Avoiding packaging, labeling, and marketing that is attractive to minors under OAR 845-025-7000;
- Avoiding advertising that can reasonably be considered to target individuals under the age of 21, including but not limited to cartoon characters, toys, or similar images and items typically marketed towards minors;
- Require all representatives or personnel of PBB to avoid selling, delivering, transferring, or



2. Please describe how your business will prevent cannabis products from being consumed around or near your business.
