To control access and to ensure no one under the age of 21 is admitted into The Green Front, multiple policies have been put into place. First, outside of the premises signage states that the premises is a 21 and over establishment. Second, upon entering the lobby patrons must provide valid identification before entering the sales floor. Employee training focusing on spotting fake ID's and an internal system that will not check-in patrons without valid identification, eliminates the possibility of an underage patron being admitted and purchasing marijuana.
