1. Please describe how your business will ensure that no one under the age of 21 is admitted, and how your business will educate patrons on the risks of marijuana use by minors.

All employees are required to hold a valid marijuana worker permit and be at least 21 years old. Signs required pursuant to O.R.S. 475B.260 O.A.R. 845-025-1245 stating "No Minors Permitted Anywhere on this Premises" will be posted at all entrances to the premises. During business hours marijuana will be stored in areas that are inaccessible to the public (i.e. display cases or behind the counters). Outside of business hours the marijuana will be stored in safes in the secured area of the premises and the premises locked and alarm armed.

Persons entering the premises will be met by an employee who will require all persons to present a valid government issued photo ID. Persons unable to present a valid ID, or who are under 21 years of age will be denied access to the premises. Any person discovered to be under 21 years old will immediately asked to leave the premises. All employees will be trained on how to check IDs and medical marijuana cards when they are hired. Employees will receive refresher training periodically. Employees who fail to comply with the minor control plan will be subject to discipline, up to, and including termination.

2. Please describe how your business will prevent cannabis products from being consumed around or near your business.

Signs complying with O.R.A 845-025-1245 and any other applicable state or local regulations shall be posted at all entries to the premises. Employees shall be trained to watch for persons opening or consuming cannabis products. Any person seen opening or consuming cannabis products on the premises shall be immediately asked to leave. The business reserves the right to refuse to admit or serve anyone who had previously opened or consumed cannabis products on the premises. Employees caught consuming cannabis on the premises, or allowing other to, shall be subject to discipline, up to, including termination.

3. Please describe how your business will prevent and address potential negative impacts to neighborhood livability such as noise, parking, garbage, or loitering from your patrons.

The premises is located in an area zoned for commercial use. The premises has off street parking, so nearby street parking should not be impacted. There are fences between the the premises and neighboring properties. Garbage cans will be provided for litter. No loitering, disruptive behavior, or consumption of cannabis on the premises will be tolerated. Persons loitering, being disruptive, or opening and/or consuming cannabis will be asked to leave immediately; if they fail to, the police will be notified.

4. Please briefly describe your business's process to respond to and resolve complaints and/or concerns from neighboring businesses or residences.

We are committed to promptly addressing all complaints and concerns from neighboring businesses or residents. We are confident that the minor control plans, plans to prevent consumption of cannabis on site, and plans to prevent negative impacts should minimize complaints. Any complaint or concern will be responded to within 5 business days, and reasonable steps will be taken to address the issue.
