2. Please describe your plan to control access to your establishment and ensure that no one under the age of 21 is admitted.

Preventing any person under the age of 21 is our top priority. There will be sign posted in multiple locations, including the entrance and in any waiting area. Proper verification and logging of ID cards upon entry at the dispensary. Any invalid ID card will be confiscated and hand over to authorities. Internal doors will be locked and will open once identification card has been verified.

3. In order to reduce the possibility of underage persons, as established by law, from gaining access to marijuana products sold at the licensed premises, please describe your plan to educate patrons on the risks of marijuana use by minors.

To prevent minors from obtaining marijuana products. Staff will be properly train to identify suspicious activities inside and around the premises. Proper protocols will be taken into action by the security officer, which includes contacting the local law enforcement if necessary. In addition clients will be provided with informations about the risks associated with marijuana use by minors and consequences of making illegal transfers of substance to minors
