- Surveillance/security system in place, with signs notifying so.
- All product stored behind the counter during retail sale hours. After hours all product is kept in safe that meets OLCC requirements, is bolted to floor and has a gps tracker.
- While customer is shopping, they have a one on one interaction with budtender.
- Procedures & policies in place to separate jobs. Cash handling & product handling are done by separate employees.
- Product & cash kept in separate safes.
- Panic buttons behind counters
- Parking lot & hallways are lighted. Hallways have security cameras.
- Battery storage for security systems meets OLCC requirements
- All product intake from vendors is done out of customers sight in a locked back room.
- Alarm buzzers under counters accessible to employees
- Alarm permit with police department

- Budtenders inform customers that consuming in public is not legal. Also inform that consuming in our hallways & parking lot are not allowed.
- Hallways & parking lot monitored by video surveillance.
- All products are required to be labeled with active ingredients and budtenders educate consumer about the products they purchase.
