Mayor Elect Wheeler would like to identify his budget priorities, advising us to look at 5% reduction of General Funds and a minimum 1% reduction of ongoing expenses.

FY 2017-18 Budget Guidance

- Prepare for an economic slowdown

- Public safety
- Affordable housing
- Transportation infrastructure

Community Input for Budget

We are looking for suggestions for improving community engagement in ONI's BAC process. Some people are unable to come to our meetings, but we would like to better engage the public. Review current list handed out, compiled by CNIC staff. DCL programs have a lot of new staff (directors and organizing staff) and have not been a part of the process yet. Steering Committee will help determine priorities.

Other suggestions:

- More language accessibility
- Spending more time on visioning and rethinking
- In depth BAC orientation for new members/staff
- Educating other elected officials
- Streamline the process for those of us that have done this year after year
- Find a way for people who cannot attend meetings to provide input
- Get people the information rather than waiting for them to come to us
- Be sure to follow up with group, including outcomes
- Provide history on ONI and BAC

ONI and Partner Organizations' Response to Recent Elections

We are a Sanctuary State, taking the step to become a Sanctuary City would be very meaningful but could impact the City budget overall. City employees are Deferred Action for Childhood Arrivals (DACA) recipients, would like to make sure that employees and other community members are safe from Immigration and Customs Enforcement (ICE). We should engage churches, synagogues, etc. when determining how to make Portland a Sanctuary City.

How do we support each other and coordinate response in response to possible hate crimes, immigrant/refugee community needs? There is the possibility of community requests for specific actions seeking ONI and/or City support. Need to be able to address growing vulnerabilities resulting from the election. ONI has participated in the past in addressing hate crimes.

- Data collection
- Hate crimes that are reported to programs/coalitions, filter into one system managed by ONI
- Listing of safe places in the City
- Create a sense of confidence, provide a safe space
- Project anti-hate language and policies
- Emergency management, provide a sense of urgency
- Connect with community members, draw everyone closer together
- Brainstorm visioning process
- Crime Prevention to participate, specifically related to fear of crime
- Uncertainty of where the hate is coming from next
- Safe houses, or symbol to recognize unification
- People, including children, living in fear – need to send out positive message of unity in Portland

Verde would like to begin working with ONI staff to collect a group to begin meeting to identify what can be done to identify and address these issues. An invite will be sent to those that attended the meeting tonight to gauge who would be interested.
