1. Please describe your plan to prevent theft at the licensed premises, including robberies, burglaries, and shoplifting.

RD Industries will meet and exceed all security requirements defined by the Oregon Medical Marijuana Dispensary Program (OAR 333-0080-1140 through OAR 333-008-1180) and the Oregon Liquor Commission Control (OLCC) Recreational Marijuana License for Retailers.

In the event of robbery, our security system will alert a 24 hour, 365 monitoring center, which will take quick response and notify the local police authority, if necessary.

Our video surveillance and video recording will meet and exceed all standards set by the OHA and OLCC. The video equipment will include the following:

- 2) 32 TB Battery Backup (capable of storing up to 60 days of HD video footage)
- 3) Monitor/Printer

At the end of each business day, all medicated products will be locked safely in safes.

2. Please describe your plan to control access to your establishment and ensure that no one under the age of 21 is admitted.

To ensure everyone is above the age of 21, we will have staff create a customer profile in our POS system, MJ Freeway. The customer profile includes the individual's first and last name, birthdate and State Issued ID number. Although the State Issued ID number is not required by the OHA/OLCC, we want to ensure that the OHA/OLCC has a mechanism to ensure everyone is above the age of 21 by auditing our POS records if necessary.

We will also have clear signage on our front door which will state, "Medical Marijuana Patients and Persons 21 and Older Permitted" and "No Person Under 21 Permitted on Premises without an OMMF Card".

3. In order to reduce the possibility of underage persons, as established by law, from gaining access to marijuana products sold at the licensed premises, please describe your plan to educate patrons on the risks of marijuana use by minors.

In accordance with the Oregon Health Authority and OAR 333-008-1500, we will include a 3"x5" informational with each purchase, that discusses the danger of marijuana to children and the importance of keeping marijuana products in a locked area away from the reach of children. Warning labels on packaging will also discourage underage misuse.

4. Please describe your plan to ensure that marijuana products sold by your business are not consumed irresponsibly in public or in the immediate vicinity of the license premises.

There will absolutely be no customer consumption of marijuana products on or near the premises. Customers will be reminded that public consumption is not legal and marijuana products must be consumed inside the safety and privacy of their own residence.

5. Please describe your plan to avoid potential negative impacts to neighborhood livability such as noise, parking or garbage from your patrons.

We will be closely monitoring incoming and outgoing traffic, which may include hiring a security service for later hours of operation. Since our location is close to private residence we want to ensure good relations by keeping noise levels down, maintaining a clean exterior presence, including a daily sweep of the property perimeter, to collect any trash or debris left by patrons.
