1. Please describe how your business will ensure that no one under the age of 21 is admitted, and how your business will educate patrons on the risks of marijuana use by minors.

Our door keeper will check everyone who enters the shop for valid ID that proves they are over 21 years of age. The reception area will be separated from the sales area by a security door. No minors will be permitted beyond the security door, and any minors or individuals without a valid ID will be asked to leave immediately.

All required posters and signs will be displayed.

Staff will be trained to inform customers of the risks to minors, and that the resale of marijuana to minors is a crime.

2. Please describe how your business will prevent cannabis products from being consumed around or near your business.

Sings at the exit door will remind customers not to do this, and that violation of this rule may lead to their being permanently banned from the business.

Our doorkeeper will monitor all exterior cameras to observe any attempt at consumption of cannabis upon the premises and nearby area. If observed, he will alert staff who will tell any offenders that the must not consume the product on site, that they must stop, and that they must leave the premises immediately.

3. Please describe how your business will prevent and address potential negative impacts to neighborhood livability such as noise, parking, garbage, or loitering from your patrons.

"Respect our neighbors" signs will be posted in a clearly visible area. Staff will give friendly reminders to customers that excessive noise is prohibited, if necessary.

Staff and management will ensure that the area surrounding the shop will be kept clear of litter and garbage.

We have six parking spaces in front of our shop, with shared access to a lot next door that has ten more spaces, as well as street parking on Multnomah Blvd.

Our doorkeeper will also be monitoring the cameras for loiterers, and any who are observed will be asked to leave the premises.
