1. Please describe how your business will ensure that no one under the age of 21 is admitted, and how your business will educate patrons on the risks of marijuana use by minors.

~Exterior facility entrance will have 12x12inch signs that state "No Minors Permitted Anywhere on premises" in English and Spanish.

~Facility will have secure lobby supervised at all times by interior and exterior security cameras and front desk personal.

~Patrons will have to present acceptable form of ID as per OLCC guidelines. These guidelines will be clearly and easily available to desk personal.

~Potential Customers who are unable to present acceptable form of ID confirming they are over 21years old will be immediately escorted off the premises.

~Secure lobby will display "Educate before you recreate" poster; "Pregnancy Warning" Posters and "Poisoning Prevention" Poster that measure 22"high and 17"wide as per OLCC policy. These signs will also be easily visible at point of sales system in dispensing area.

~Once proof of age 21yrs or older has been verified a bud-tender will come out from a security locked door and escort customer back to dispensing area.

~All marijuana items for sale will be sold in a child proof container and if the container is not child proof customer will be required to purchase a child proof ziplock container for this item.

No packaging or labeling will be attractive or worded in a way that is attractive to minors. We will also make sure that all packaging is not misleading or untruthful.

~Prior to final transaction bud tender will perform a second identification check to assure that the customer is indeed over 21years of age. If this is questionable or they are not over 21 they will be immediately escorted out of the premises.

2. Please describe how your business will prevent cannabis products from being consumed around or near your business.

~Signs will be posted on Exterior of facility, point of sales areas, and at exit that state, "No on site Consumption" and "Marijuana infused products may not be consumed in public" per OLCC requirements.

~Security cameras providing views of interior and exterior of facility along with supervision by front desk personal will insure that there is no consumption of marijuana products on site or within view of premises. Managers will also do exterior and interior visual inspections periodically to insure there is no consumption of marijuana products or other prohibited activities in or around facility.

~If any staff member does observe consumption of marijuana products on or around premises they will approach the individual and request that they cease consumption and vacate the premises immediately. If there is a safety concern staff will notify law enforcement.

3. Please describe how your business will prevent and address potential negative impacts to neighborhood livability such as noise, parking, garbage, or loitering from your patrons.

~facility has parking lot which provide limited number of designated off-street parking.
~facility will provide garbage cans and dumpsters that will be emptied daily and weekly as other retail business in the area. Employees will do regular walk throughs of interior facility and exterior facility for garbage and other debris and keep facility grounds neatly appearing at all times.

~Noise level will be minimized by preventing loitering outside by regular staff presence during regular timed inspections for on site marijuana consumption and garbage patrol.

~Security videos cameras will record and assist staff in monitoring of exterior of building perimeter to ensure prohibited or destructive activity can be observed, prevented and/or ceased immediately.

~To prevent odor concerns we will have Air Filtration system and applicable permits
