1. Please describe how your business will ensure that no one under the age of 21 is admitted, and how your business will educate patrons on the risks of marijuana use by minors.

Today's Herbal Choice is supervised during all business hours by employees, who check persons valid I.D. Every persons I.D is checked regardless of how old that person appears to be. All areas where usable marijuana is transfered or sold is clearly labeled with signs on the door that read "Do not enter limited access area". Doors that are accessing the dispensing areas are secured by commercial grade, key-pad locks that require a code to unlock, code is held by authorized personnel only and the code is changed on a regular basis.

With every at Today's Herbal Choice includes a 3x5 inch card that states information about the negative effects of marijuana use on minors and pregnant women. All product are kept in a opaque, smell proof packaging and labeled in bold lettering "Warning for use by adults 21 and older. Keep out of reach of children it is illegal to drive a motor vehicle while under the influence of marijuana". It also has the universal marijuana symbol in color. There also is proper sign-age in the dispensing show room that state all the risks and educate before you recreate.

Should we have an issues with our patrons, we attempt to hanlde it prior to that person leaving the premises and should the confrontation become unsafe or violent, Portland Police will be contacted.
