RENEWING YOUR MARIJUANA REGULATORY LICENSE

Please submit your complete renewal application to the Cannabis Program **at least 45 days before your current license expires:**

- Renewal Information Form (pages 2-3 of this document)
- All items required in Section 2: (including a [Marijuana Regulatory License Application](#), [Personal History Form](#) and, for Medical Dispensaries and Marijuana Retailers, a [Marijuana Control Plan](#))
- Any items listed in Section 3 that have changed
- Renewal application fee (see fee schedule below) *The renewal licensing fee will be paid if and when your business passes the inspection and your application meets the City's licensing requirements set out in Portland City Code 14B.130.*

You may submit renewal materials and application fee in person (cash, check, or credit) or by mail (check only) to:

To continue operating legally, you must submit the Renewal Information Form, Marijuana Regulatory License Application, other required documents, and the application fee at least 45 days before your current license expires to ensure it is renewed before your current license expires.

If you do not submit your application at least 45 days before your current license expires, you must cease operations after your expiration date until the Cannabis Program finishes processing your renewal application and issues a renewal license.

If you do not submit complete renewal application materials before your current license expires, you will have to cease operations, your 1,000-foot buffer will be forfeited (for Retailers and Medical Dispensaries), and you will need to apply for a new Marijuana Regulatory License.
