1. Please describe how your business will ensure that no one under the age of 21 is admitted, and how your business will educate patrons on the risks of marijuana use by minors.

The Green Planet has a zero tolerance policy for employees serving Marijuana products to minors.

Staff are not permitted to give, sell or serve product to a minor in/or on the premises. Management and staff of the licensed facility are responsible to ensure Marijuana is not sold or provided to minors under the age of 21. Staff are required to ask for acceptable forms of identification (per The Green Planet Policy) from patrons and all visitors they must check in and provide valid identification and then be logged and entered into our Greenbits Software on completion of purchase. Any questions regarding valid ID are always directed to a management staff member. Although 21 is the legal age to purchase Marijuana The Green Planet has a policy to check all IDs to verify that they are current and valid regardless of age.

2. Please describe how your business will prevent cannabis products from being consumed around or near your business.

We have several cameras that monitor parking lot activity and break areas. If a person is doing suspicious activity one of The Green Planet's management team will address the situation and note that the patron is no longer allowed to be on The Green Planet property at any locations. There is also a policy in place that if an employee violates the rule they are suspended immediately so we can review footage then terminated if found in violation.

3. Please describe how your business will prevent and address potential negative impacts to neighborhood livability such as noise, parking, garbage, or loitering from your patrons.

The Green Planet has a strict policy of no loitering around the property. With our 24 hour surveillance we are able to contact the appropriate authorities to address any issues that occur on our property during or after business hours. In regards to maintenance of the property we have a separate maintenance crew that will address any issues to parking or garbage.
