1. Please describe how your business will ensure that no one under the age of 21 is admitted, and how your business will educate patrons on the risks of marijuana use by minors.

Patrons will have their identification credentials (ID) checked in the lobby upon entry into the business. Only upon verification by an employee that the ID is both valid and the patron is over the age of 21 (or 18 with a valid OMMP card) will the patron be admitted into the Limited Access Area. Employees will be trained in forms of ID that are acceptable under applicable law and in how to determine the validity of ID. The 21 and over age restriction will be clearly indicated via signage in Spanish and English posted at the door, within the lobby, and within the Limited Access Area. An individual will need to go through an auto-locking door to access the Limited Access Area after their ID is checked.

In addition to required labeling on products regarding use of marijuana products, clear signage will be used in the store notifying patrons of the risk and illegality of marijuana use by minors.

2. Please describe how your business will prevent cannabis products from being consumed around or near your business.

Clear signage will notify patrons and passer-by that the consumption of cannabis products on or around the premises is prohibited and that video surveillance is being used. OLCC compliant exit packaging will be used and employees will be specifically trained on this issue.

Constant video surveillance as it complies with all state and local requirements will be installed. The security system in place will include sufficient angles and resolution of the surveillance.

Anyone caught consuming cannabis products or or around the premises will be prohibited from entering the business in the future and the police will be contacted as appropriate.

3. Please describe how your business will prevent and address potential negative impacts to neighborhood livability such as noise, parking, garbage, or loitering from your patrons.

Our business will continue to be a quiet business. No excessive music or other noise will emit from our business.

We intend to continue to be a welcome and friendly business in our neighborhood and will train all staff to ensure that they respect our community and neighbors and that any patrons who fail to also respect our neighbors are corrected or prohibited from returning to our shop.

We will comply with all applicable packaging laws. Our marijuana products will be packaged to conceal the product from public view and, because our patrons will know they are legally prohibited from consuming on-site, the products will remain concealed from public view and will not create litter in the neighborhood.

Our neighborhood is commercial with ample parking available to our customers and our shop has not caused any issues with parking.

4. Please briefly describe your business's process to respond to and resolve complaints and/or concerns from neighboring businesses or residences.

The owners and operators plan to be very involved in the day to day operations of the business. We will ensure our neighbors have access to us by email, telephone, face-to-face communication, etc., and feel comfortable raising any concerns they may have to us. We will prioritize addressing any such concerns in a respectful way that maintains positive relationships.
