Every person who enters the store is subject to immediate verification of ID. Appropriate signs as required by law are posted and visible before a patron enters the store in various languages advising of the age requirements and ID's are verified.

An employee sits at the front desk to verify and monitor patrons as they enter the store. Additionally, offsite monitoring of the cameras by support staff ensure no one is missed.

Only valid government issued ID's are permitted.

Signs and education cards are supplied at the point of sale to inform patrons of the risks of use by minors.

Camera's are stationed at all exits and monitor the parking lot and all surrounding areas. Monitors are under constant surveillance. Additionally, staff walk the parking lot and perimeter of the store at least once every hour.

Our store has more than 20 parking spots in the lot and we are set back from the main street. We have regular maintenance employees dedicated to the upkeep of the surrounding areas.
