Salem Hyacinth, LLC, dba Wildweed, will maintain a check-in area outside of the limited access area, compliant with Oregon Liquor Control Commission and City of Portland regulations, where all guests must present government issued photo ID to document they are age 21 or older, prior to be allowed into the limited access area. Check-in receptionist will be trained and provided identification tools to recognized invalid ID.

Signage will be posted, compliant with OAR 845-025-1245, that no person under the age of 21 are allowed in the premises.

The education of the risks of cannabis use by minors will include:

- Flyers and/or handouts explaining the risks of cannabis use by minors
- Safety child resistant packaging with prominent labeling to keep away from minors
