Subject: Quick Look at Timeliness of Recent Investigations

---

You asked that I take a quick look at the timeliness of some recent investigations. I queried our database using closing dates between 11/01/14 and 2/28/15. There were 23 full investigations that closed during those four months. I'm attaching the 'tracking' tab printouts from each of those cases.

Four months and 23 investigations might be a limited view – so I'm hesitant to draw too many conclusions – but here are some quick thoughts. Details are included in the Appendix.

### **Overall:**

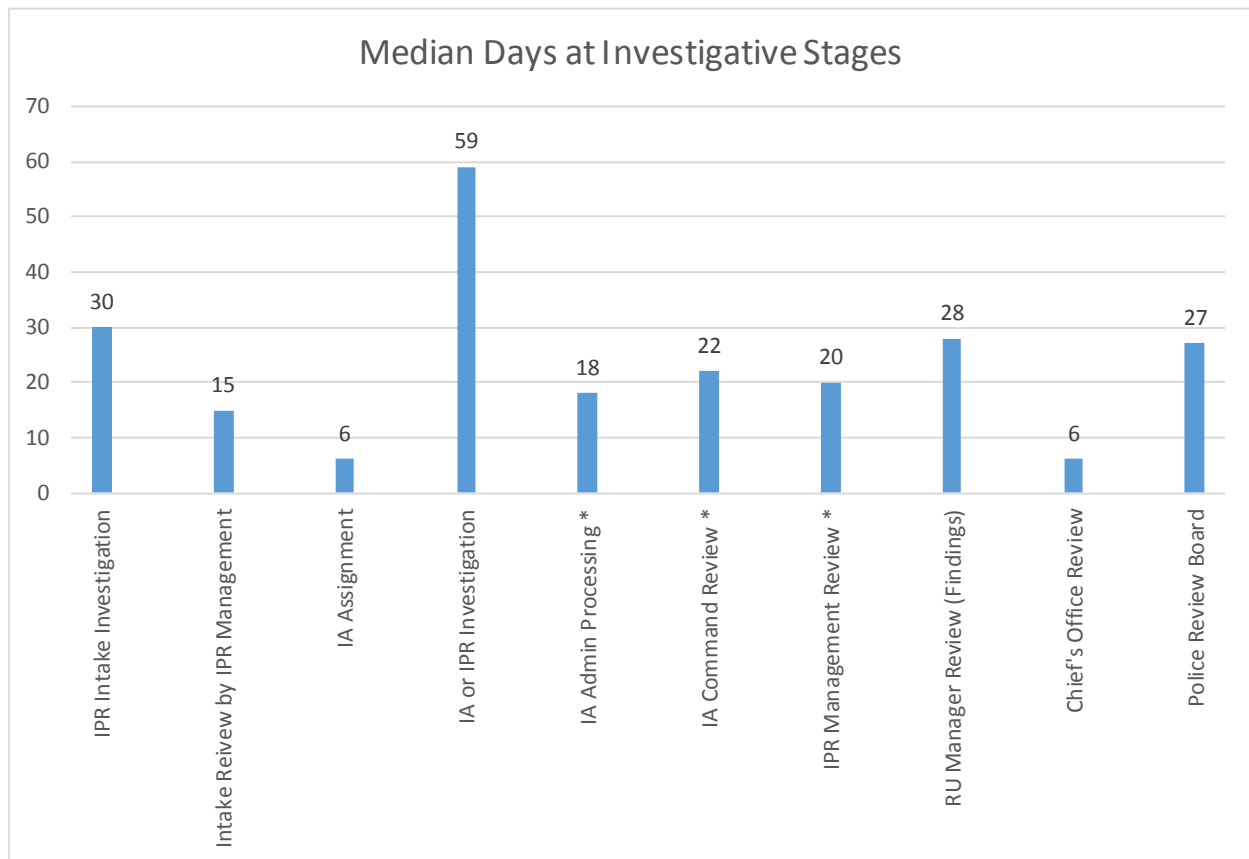
Only two of the 23 were completed within 180 days per DOJ's definition (reported date → Chief's decision); two others were between 180-200 days. The overall median was 319 days to IPR/IA closing dates, or 263 days using the DOJ definition. It appears that substantial changes are still needed to consistently meet the 180-day target.

### **Intake/Investigation:**

The primary investigation phases of these cases are generally well contained. The data shows a median time of 59 days for investigations by IPR or IA. Community complaints that initiate with IPR have a median intake time of one month (plus two weeks of management review) before a full investigation gets underway. In many of those cases, however, IPR lays the groundwork that allows the full investigation to proceed more quickly. For example, IPR typically interviews the complainant and civilian witnesses, while IA would perform those steps in cases that initiate at the Bureau. As a result, the median time for an investigation that was preceded by an intake is somewhat shorter.

### **Administrative Processing:**

This is a recently added tracking stage. It tracks the time that IA takes to prep a file for consideration by a Reporting Unit (RU) manager, the Chief's Office, or the Police Review Board (PRB). The median days of all stop at 'Processing' is 4 days, however, there were some long stops noted (20-35 days). Also, on most of these investigations, a case may have 3-5 stops at Processing. The median for total time at Processing per case is 18 days.



\* A fully-investigated case typically spend days at the IA Admin Processing, and IA and IPR Review Stages two to four times. The median numbers shown are the sum of those days.

### Findings:

Reporting Unit (RU) managers are taking a bit longer to review cases and write their proposed findings (when comparing this sample of cases against a previous study). Two weeks is the suggested timeframe. The median was three weeks when calculated in 2011. The median in this current sample is four weeks, and four cases exceeded 50 days at this stage.

### Reviews of the case/findings:

Intakes are reviewed IPR management; Investigations are review by IA and IPR management; Findings are reviewed by the Chief's Office, IPR management, and IA management; and PRB results are reviewed by all. Most of these reviews are handled fairly quickly – but the sheer number of these passes of the baton add up. Some of these review are now scheduled to run concurrently, which I think has helped. The median for combined IPR Management Reviews was 20 days, for IA Command Reviews it was 22 days, and for the Chief's Office it was 6 days. It is also important to note that the IPR and IA Reviews (similar to Processing) are typically repeated 2-4 times during a case's lifecycle. The median for all stops at those stages (considered individually) is six days for IPR and five days for IA.

Occasional reviews can take much, much longer. For example, one IPR Management Review was 78 days and one Chief's Office Review was 77 days. I looked into these outliers for more information, and there appears to be more going on in these cases. For example, the IPR Review might have been more accurately tracked to an outside jurisdiction as the case was held up while criminal findings and sentencing against the officer were finalized (so those materials could become part of the administrative investigation). The long Chief's Office Review may have been due to the transition in chiefs or possibly a wait on some opinion/advice from the City Attorney's Office. Cases often see a long delay (see below) at the Discipline Stage as the Police Commissioner's (Mayor's) and City Attorney's Offices are consulted. In this case, they may have been consulted earlier in the process.

**Police Review Board:**

Scheduling and holding a PRB takes a median of 27 days per case. However, a few of these are very long waits (160 days; 101 days). I do not have a solid understanding of why a few cases take that long.

**Citizen Review Committee:**

If a case was appealed to the Citizen Review Committee (CRC), the added time was substantial. Their process takes several months and is sometimes repeated if they feel an investigation was inadequate. The proposed City Code changes could make a significant impact here. This might be a bit of an anomaly, but there were two cases in this sample that were heard in front of CRC twice each. The median time was 84 days per hearing, or 161 days per case. That time does not include the 30-day appeal window.

**Discipline and/or Officer Debriefings:**

As mentioned above, if discipline (and to a lesser extent officer debriefings) are involved - those stages can extend a couple months beyond the 'end' of a case. The data shows a median of 50 days for any individual stop at this stage. One case cycled through this stage twice, so the combined (or case-level) median was actually 71 days.
