

Open Cases 129+ Days Old Listed by Current Assignment

Background: The City's Settlement Agreement with the USDOJ stipulates that investigations of officer misconduct will be completed (through the Police Chief's findings) within 180 days. This report was envisioned as an early warning of cases that are likely to go over that timeline. The report uses 129 days to allow time for the parties to appeal to the Citizen Review Committee (30-day window to make that decision*) and time for that committee to conduct any appeal (21 days per City Code). **[129 days + 30 days + 21 days = 180 days]**. For more information about any of the various stages listed below, or the complaint process in general, please be in touch with the Independent Police Review.

* City Code was recently ammended to reduce the 30-day appeal decision window to 14 days.
