**1. Independent Police Review (IPR) Work Plan / Accomplishments**

**IPR Hires Two Investigators**

In the last month, IPR has been fortunate to have IPR Investigators Andrew Pease and Casey Clithero start.

**Andrew Pease** received his Bachelor's degree in Communications from the University of Idaho, and served five years of service in the Army. During his time in the military, Andrew was stationed in South Carolina, Louisiana, and Korea, but has also lived in Texas and Idaho. Andrew has experience working with a variety of state and local governments.

**Casey Clithero** spent ten years overseeing student conduct and investigating sexual misconduct at Southern Oregon University. Casey also serves as an instructor in the Sexual Assault Training Institute for Oregon's Sexual Assault Task Force. He received his B.S. in English from Southern Oregon University in 2003, and his Master's in Higher Education Administration from Ball State University in 2005.

**IPR Releases O'Dea Investigation**

In November, IPR released its investigation into the off duty shooting of a friend by former Chief Larry O'Dea. During the investigation, IPR staff interviewed over 20 witnesses, subpoenaed phone records, and traveled to Harney County to interview witnesses.

Due to the wide range of interest in our community, IPR made the completed investigation available on its website.

**Citizen Review Committee Volunteer Recruitment and Selection**

The Citizen Review Committee (CRC) recruitment ended on October 26<sup>th</sup>. IPR received 25 applications for five positions. The applicants represent the diversity of Portland with many backgrounds and cultures represented in the applicant pool. Twelve applicants were interviewed and the finalists will be announced in January.

IPR Community Outreach Coordinator Irene Konev attended the Fix-it Fair at Ron Russel Middle School, and connected with community in SE Portland. She also met with staff of Gateway Domestic Violence Center and Coalition of Community of Color to plan further outreach.
