**1. Independent Police Review (IPR) Work Plan / Accomplishments**

**IPR staff grows**

Thanks to City Council's support during the City's fall budget adjustment process, IPR has added one investigator and one management analyst position to its ranks. The additional investigator will bring IPR to eight complaint investigators. In the last five years, IPR has gone from 2.5 investigator positions to eight full time investigators. The additional investigative resources have allowed IPR to dramatically increase the number of administrative investigations that it conducts. The additional management analyst will allow IPR to increase its capabilities in providing policy recommendations to the Police Bureau as well as providing more police accountability data to the public through our website.

**CRC Resignation**

IPR would like to thank Marisea Rivera for her contribution to the CRC. Her thoughtful consideration of information, warm engagement with community, and advocacy for people with disabilities. She will be missed.

**Outreach**

IPR Community Outreach Coordinator Irene Konev attended and networked at the Emily G. Gottfried Human Rights Award, and the Slavic Advisory Council five-year anniversary celebration. She also attended the PDX Women in IT Women + Tech Holiday Party where 450 women gathered for networking.

**Citizen Review Committee Volunteer Recruitment and Selection**

IPR welcomes back two current members of the CRC, Kristin Malone and Julie Falk for a second term. Two new members will be announced in February, upon passing their background checks.

The selection committee consisted of former CRC members Steve Yarosh and Jeff Bissonnette and current CRC member Roberto Rivera. Other members included Salome Chimuku Program Manager at the Criminal Justice Policy Research Institute at PSU, Dani Ledezma Interim Executive Director of Coalition of Communities of Color, Laura Orr Legal Research and Public Law Library Consultant, and IPR Assistant Program Manager Rachel Mortimer. The selection committee reviewed 25 applications and interviewed the twelve of highest ranked candidates. They chose two new members to be recommended for current openings to Council appointment, and selected three applicants to hold in reserve should there be any member resignations within the term.
