1. Independent Police Review (IPR) Work Plan / Accomplishments

OIR Report

The Office of Independent Review (OIR) is scheduled to present their report to City Council on February 15th at 2:00 pm. IPR will be holding a forum for community to give feedback on the report on February 14th in the Rose room, on the third floor of City Hall from 2:00 to 3:00 pm. IPR will launch the OIR report to the public later this week.

CRC Appointments

The Independent Police Review is pleased to announce that Kristin Malone and Julie Falk were reappointed to the CRC and two new members Albert Lee and Vadim Mozyrsky were appointed by City Council to serve three-year terms. Their bios are found below:

Kristin Malone received her Bachelor of Arts degree in Liberal Arts from Sarah Lawrence College and her law degree from The University of Texas School of Law. She served as a judicial law clerk to the Honorable John M. Rogers of the United States Court of Appeals for the Sixth Circuit, where she analyzed federal appeals of both civil and criminal matters. Ms. Malone practiced law in Seattle prior to joining Portland firm Markowitz Herbold, PC in 2014. Ms. Malone is a Founding Member of the Women's Foundation of Oregon and a proud supporter of the Lawyers' Campaign for Equal Justice. She lives in North Portland.

Julie Falk is a graduate of Swarthmore College where she majored in English Literature and Art History. She is the executive director of Bitch Media and is president of the board of Women's Foundation of Oregon. She previously served as executive director of the Center for Health Justice in Los Angeles and the Prison Media Fund in Cambridge, Massachusetts. Originally from Kentucky, Julie moved to Portland in 2006, where she lives with her husband and two children.

Albert Lee received his Bachelor of Arts degrees in Political Science [International Relations] and History from Creighton University and his law degree from The George Washington University Law School. After working for the American Bar Association in Washington, DC, he returned to Portland with his family. He is now the Dean for Business & Computing at Portland Community College. In that role, he is tasked with management of faculty & staff, adjudication of academic matters, provision of leadership of multiple educational programs, development and administration of budgets, development of community relationships, among many other duties. An army brat, he was born in South Korea, has lived in many parts of the United States, and traveled to many parts of the world.

Vadim Mozyrsky graduated with Bachelor of Arts and law degrees from the University of Texas. After law school, he clerked at the Texas Court of Appeals, the United States District Court for the Southern District of Texas, and the Supreme Court of the Republic of Palau. Mr. Mozyrsky worked in private practice before joining the federal government as a senior policy advisor with the Department of Health and Human Services and, currently, as an administrative law judge with the Social Security Administration. He is actively involved in the Portland community, including serving on the Portland Commission on Disability, participating in the steering committee for Project SEARCH, and organizing the Portland Film Festival.

New CRC Member Orientation

Before being appointed to serve their three-year terms, the new CRC members went through extensive training to learn about their role on the CRC. The topics covered included, history and formation of IPR, introduction to the Auditor’s Office, Internal Affairs, and Police Review Board. CRC volunteers and alternates also took six hours of cultural competence training. They attended legal training on public meeting laws and communication. They also learned about case file review. New members expected to attend a Ride-along with a police officer to further their training.

IPR Outreach

In addition to coordinating the CRC orientation, IPR Senior Community Outreach Coordinator attended and networked at the 33rd Anniversary MLK Tribute at Highland Church, Slavic Advisory Council meeting and at Khabarovsk Sister City Association meeting. She also coordinated the first Slavic & Eastern European Heritage Week Proclamation by working with members of City Council, City of Portland employees of the Slavic Empowerment Team and community leaders.
