The City Auditor has named Ross Caldwell as the new Director of the Independent Police Review. Caldwell has worked at the Criminal Justice Commission since 2015, overseeing the Justice Reinvestment Grant Program and several other program areas and has worked extensively with the different criminal justice system associations and counties around the state.

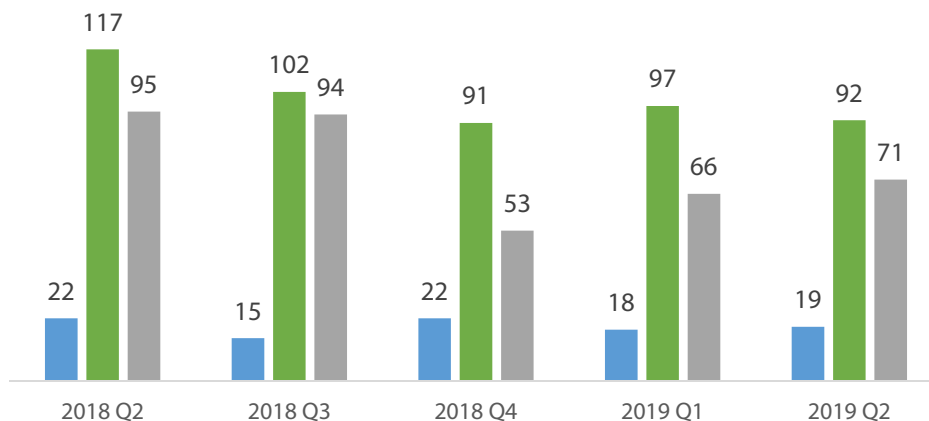
Prior to the Criminal Justice Commission, Ross worked as a Deputy District Attorney in Multnomah County. He grew up in Toledo, Washington and went to college at the University of Washington and law school at Lewis & Clark College. Caldwell starts as IPR Director on July 29.

Second Quarter Data

Preliminary Count of Bureau Complaints, Community Complaints and Commendations



IPR and Internal Affairs received 92 complaints from community members and 19 bureau complaints that did not involve community members during April, May, and June of 2019. Community and bureau members also filed 71 commendations during that period.

During this quarter, Internal Affairs also processed a significant backlog of commendations which accounts for changes in the previous quarters' totals.



Community Complaints

Eighty-two of the community complaints were received by IPR and 10 came through Internal Affairs. IPR opened one case as an independent investigation, Internal Affairs is investigating seven cases and intake is ongoing for 27 complaints. Twenty-eight complaints were administratively closed, most commonly because no misconduct was identified. Fifteen complaints were referred to officers' supervisors for investigation and twelve were referred to precinct commanders for follow-up. Two complaints entered mediation this quarter.

Bureau Complaints

Of the 19 cases reported by Bureau members in the second quarter, seven are being investigated by Internal Affairs and two by IPR. One case was closed and intake is ongoing for four complaints.

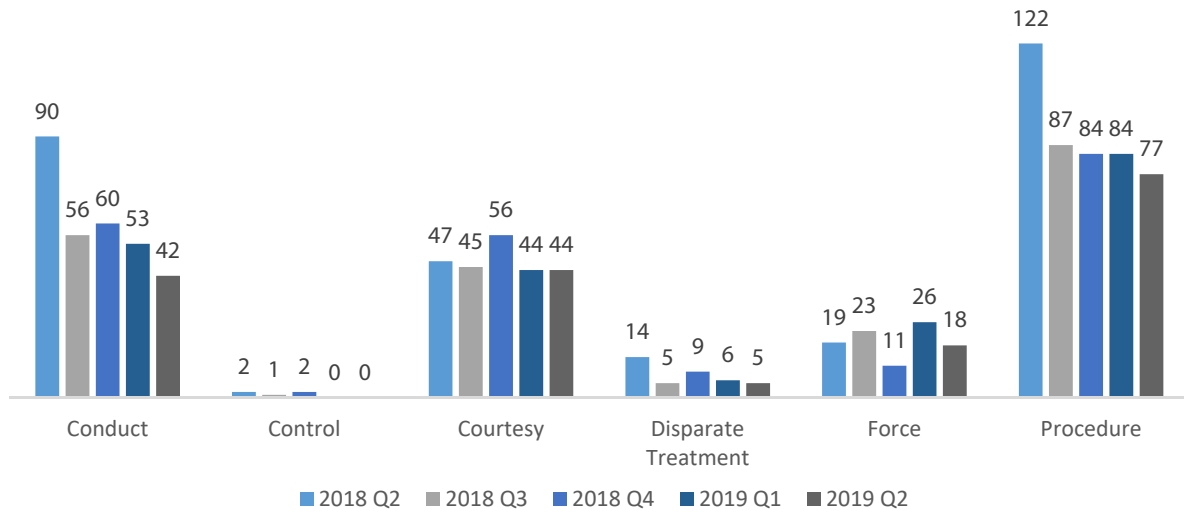
Status of 2019 Q2 Bureau Cases



Community Allegations

Though many cases are still in progress and additional allegations will likely be added, community complaints made in the second quarter of 2019 contained 186 allegations.

Findings in Community Cases

Findings were completed for 52 allegations from community members (from 19 full investigations) in the second quarter of 2019. Twelve percent (6) of those allegations were sustained.

Cases that are referred to supervisors for investigation also receive findings. In the second quarter of 2019 findings were completed for 33 allegations from 19 cases sent for supervisory investigation. After talking with complainants, supervisors found two of the allegations to be substantiated and 31 unsubstantiated. All of these allegations dealt with potential conduct, courtesy or procedure violations.
