Community Outreach

IPR Senior Community Outreach Coordinator Irene Konev attended, networked and recruited volunteers to serve on the Police Review Board at Elders in Action, Muslim Advisory Council, Oregon Leadership Summit, Mulugeta Seraw Commemoration Conference and at a Fix-it Fair held at Madison High School.

Konev and IPR Program Manager Assistant Rachel Mortimer presented on the IPR commendation/complaint process to crime prevention staff of Office of Community and Civic Life, formerly known as Office of Neighborhood Involvement.

To hear directly from community members contacted by police, Konev coordinated forums, focus groups and dialogues for feedback on the Homeless Profiling Policy Review. IPR Director Constantin Severe and IPR Analysts KC Jones and Molly Christmann heard from staff and program participants of Sisters of the Road, Outside In, Latino Network and City of Portland Tribal Liaison Laura John.
