**1. Independent Police Review (IPR) Work Plan / Accomplishments**

**New Citizen Review Committee Member Orientation and Training**

New CRC members and alternates were selected by the Auditor. Training and orientation have been scheduled for late January and early February.

**Outreach**

IPR Senior Community Outreach Coordinator Irene Konev is the co-founder of the Slavic Empowerment Team which is an employee affinity group of Diverse and Empowered Employees of Portland. Through her leadership of this team, a Slavic Eastern European Heritage Week proclamation was written, and today the Mayor read the proclamation in Council to proclaim the second week of January as the week to celebrate Slavic and Eastern European culture in Portland. This marks the third annual proclamation. She worked with city staff and IRCO staff to put on a celebration at IRCO. Konev also engaged with staff from Latino Network and Lifeworks Northwest.

Konev completed the eight-month training on Results Based Accountability on Equity. She also completed the Train-the-Trainer of the same program in December with a cohort of other City staff who are poised to make this training available to other staff at the city.
