Independent Police Review (IPR) Work Plan / Accomplishments

IPR Operations During COVID

Due to the ongoing public health crisis, all IPR staff are working remotely. Although the IPR office is closed to in-person visits, investigators are available to accept complaints online, by phone or by mail.

Policy Reviews

IPR released a review of PPB's Weapon Flashlight Policy last month.

Community Outreach

IPR Senior Outreach Coordinator Irene Konev engaged with community and coordinated meetings to expand awareness of IPR. IPR Staff met with JOIN, (an organization that assists the houseless community) and built awareness of IPR with other organization such as El Programa Hispano, YWCA, Native American Rehabilitation Association, Urban League and Catholic Charities. Staff also met with newly elected to the Portland City Council, Carmen Rubio. Konev also attended the Portland Committee on Community-Engaged Policing.

OIR Group Report

The OIR Group will submit their review of officer involved shootings to the city this month. IPR will publicly release the report and it will be presented to City Council at the September 30, 2020 meeting.
